Now, therefore, as approved by the Divisional Departmental Promotion Committee and cleared by GAD (Vigilance) vide O.M. No: GAD (Vig) 14-NOC/2018-Edu Dated 04/06/2018, sanction is accorded to the regularization/confirmation of the aforesaid **03 (three)** I/C Junior Assistants as Junior Assistants in the pay band of Rs.5200-20200 with grade pay of Rs.1900/- (Pre-Revised) on the posts held by them w.e.f. 01/10/2017.

- The regularization shall be without prejudice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.
