

Whereas, the Chairman Crescent Public School Naseem Bagh (Srinagar) has approached this office to grant permission to run the classes from 6<sup>th</sup> to 8<sup>th</sup>.

Whereas, the Chief Education Officer Srinagar vide his letter No. CEO/Gen/5067 dt: 30/4/2015 while submitting the inspection report of the school conducted by the Principal BHSS Hazratbal reported that the Crescent Public School Naseem Bagh Srinagar, has been given affiliation by the J&K State Board of School Education to run the classes upto 10<sup>th</sup> vide resolution No. F(/Fac/Gen-B) 15/KD dt: 23/4/2015 and the Administrative Department vide order No. 280-Edu of 2014 dt: 12/3/2015 has allowed to run the classes upto 12<sup>th</sup> standard.

Whereas the school was permitted the registration from Class 1<sup>st</sup> to 5<sup>th</sup> by the Chief Education Officer Srinagar vide No. CEO/Gen/Recog/15 of 2015 dt: 20/2/2015.

Whereas, the inspection team recommended to grant extension in favour of the school to run the classes upto 8<sup>th</sup> as the extension shall not affect on enrollment of surrounding Govt. run schools.

Whereas, a committee of three officers was constituted vide order No. 17 DSEK of 2016 dt: 8/1/2016 to examine the circumstances in which the recognition matter was skipped from level to level in respect of Crescent Public School Naseem Bagh and got Class 9<sup>th</sup> and 10<sup>th</sup> affiliated with BOSE and 11<sup>th</sup> and 12<sup>th</sup> from the Administrative Department without getting class 6<sup>th</sup> to 8<sup>th</sup> recognized.

Whereas, the committee reported that the school is running in a spacious complex and has state of the art infrastructure. The statement of the owner/ patron was taken as black and white, and the school is running classes from 1<sup>st</sup> to 12<sup>th</sup> grade. However for classes 6<sup>th</sup> to 8<sup>th</sup> no permission has been granted by the Director School Education Kashmir.

Whereas the committee further reported that the owner of the school during inspection revealed that initially he wanted to run higher secondary classes which was later extended to primary classes and had no infrastructure to start classes from 6<sup>th</sup> to 8<sup>th</sup> and this was only done on the instance of parents and therefore required infrastructure was managed.

Whereas the committee informed that in the present circumstances, the school qualifies for permission to run classes from 6<sup>th</sup> to 8<sup>th</sup> given huge infrastructural facilities and recommended to grant permission to run the classes from 6<sup>th</sup> to 8<sup>th</sup> as the students from these classes are already on the rolls in the school.

Now, therefore in the back drop of the report and recommendation made therein by the enquiry committee, post facto sanction is accorded to run the classes from 6<sup>th</sup> to 8<sup>th</sup> in favour Crescent Public School Naseem Bagh subject to the following conditions:-


- i. seek registration with the competent authority under the relevant provision of the J&K Shops and Establishments Act,

- iii. not effect any upward mid-term revision in any component of the said fee structure,
- iv. pay reasonable salary to the teachers and other staff and payment thereof shall be made only through cheque,
- v. the salary structure so allowed shall be duly notified, along with other service conditions including inter alia matters of CP Fund leave of different kinds Pension Gratuity etc as the case may be ,
- vi. arrange regular in-service training of teachers including orientation and refresher Courses on the basis of actual need from time to time,
- vii. Institute an appropriate mechanism to ensure that services of teachers or other staff are not dispensed with at will without due regard to the principles of equity and fair-pay.
