Sub:- Select list of the candidates for the post of Teacher (Education Department) District Cadre Pulwama in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 315, 466 & 434) respectively and cancellation of Provisional appointment thereof.

Whereas, the Administrative Department vide letter No. Edu-1/347/2014 dated 24.10.2014 forwarded the list of 279 candidates selected as Teachers for District Cadre Pulwama pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/8971-77 dated 18.10.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department in their earlier communication No. Edu-1/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

- The salary in favour of the selected candidates is only drawn:-
- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the
  appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated
  against the candidates.
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the Judicial Magistrate.

Whereas, in light of above instructions of the Administrative Department all the selectees in whose favour the selection was released by the SSB were advised to furnish their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in the Directorate of School Education Kashmir for favour of further necessary action in response to DSEK's notification No. DSEK/Estt/III/B-Trs/50/2014/Sel/Pul Dated 17/11/2014.

Whereas, in response to this office notification dated: 17/11/2014, 186 (Out of 206) furnished their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in this Directorate and accordingly this office issued provisional appointment orders in favour of 186 candidates vide Order No. 18-DSEK of 2015 dated 03.01.2015 with the rider that they will report to Chief Education Officer Pulwama for further posting. Besides vide order No. 148-DSEK of 2015 dated 24.01.2015 and No. 792-DSEK of 2015 dated 26.03.2015 the provisional appointment orders in favour of 20 & 24 selectees respectively has been issued as their selection was released later in phased manner vide various communications;

Whereas, in all 06 (Six) selectees (detailed below) have failed to join in the CEO Office Pulwama or in the respective places of postings where they were adjusted after issuance of provisional appointment orders in their favour as intimated by Chief Education Officer Pulwama vide No. CEO/Pul/Estt/TNG/15/1751 dated 20.02.2015;

Whereas, vide this office Notification No. DSEK/Estt-III/B-Trs./39/2014/Sel/Kup/PF/4376-77 Dated 12/02/2015, these 06 (Six) candidates who failed to join in CEO Pulwama/respective places of posting within the stipulated time, were given final opportunity through print media to join their duties within one week from the date of publication of the Notification failing which it shall be presumed that they are not interested to join the Department and the resultant slots shall be filled up by utilizing wait list in respective categories;

Whereas, in response to the notification dated 12/02/2015, no selectee showed his interest to join the department and the matter was accordingly taken up with the Administrative Department vide letter No. DSEK/III/B-Trs/39/2014/Sel-Kup/PF/4540-41 dated 02.03.2015 for obtaining necessary instructions;

Whereas, in response to the aforementioned communication dated 02.03.2015, the Administrative Department vide letter No. Edu-I/288/2014, dated 30.03.2015 has conveyed instructions for operating wait list against the slots which became available due to non-joining/non-depositing of undertakings of selectees and to cancel the appointment orders issued in favour of the candidates who failed to join their duties;

Now, therefore, pursuant to the instructions of the Administrative Department conveyed vide communication dated 30/03/2015, the provisional appointment order issued in respect of **06** (Six) candidates (detailed above) vide Order No. 18-DSEK of 2015 dated 03.01.2015 and No. 148-DSEK of 2015 dated 24.01.2015 is hereby cancelled with immediate effect.
