Whereas, pursuant to the approval of General Administration Department conveyed vide O.M.No. GDC-106/CM/2018 Dated 06/07/2018, the Administrative Department vide G.O.No. 853-Edu of 2018 Dated 07/09/2018 issued under No. Edu/L/K/188/2015 Dated:- 07/09/2018, accorded sanction to the appointment of 06 (Six) candidates (petitioners) as Teachers in the pay scale of Rs 5200-20200 +GP 2800 in District cadre Budgam, notionally from the date private respondent No's. 05 and 06 in the petition were appointed vide DSEK Order No. 503-DSEK of 1999 Dated:- 31.03.1999 on the recommendations made by the Services Selection Board in pursuance of Advertisement Notice No. 03 of 1996 dated 24.12.1996 and No. 08 of 1997 dated 09.09.1997 and regularly from the date of issuance of appointment order, after grant of relaxation of upper age limit;

Whereas, the Administrative Department in the endorsement of the said Order directed to issue appointment orders in favour of the candidates strictly as per the approval conveyed after fulfilling all the codal formalities;

Whereas, vide this office order No. 1215-DSEK of 2018 dated 15.09.2018, Five candidates were provisionally appointed as Teachers in District Cadre Budgam in relaxation of upper age limits in the pay scale of Rs.5200-20200 with grade pay of Rs.2800, on probation for a period of two years;

Whereas, the Chief Education Officer Budgam vide above referred to communication has forwarded the verification reports of documents/certificates in respect of Five candidates for issuance of confirmation/formal appointment order.

Now, therefore, on the basis of verification report of certificates/testimonials furnished by the Chief Education Officer Budgam, sanction is hereby accorded to the confirmation of the provisional appointment order in respect of the following Five (05) candidate who stand provisionally appointed as Teacher in District Cadre Budgam vide Order No. 1215-DSEK of 2018 dated 15.09.2018, notionally from **31.03.1999** (i.e. the date private respondent No. **5&6** in the Petition were appointed vide DSEK Order No. 503-DSEK of 1999 dated 31.03.1999) and monetarily from the date they have assumed the post of Teacher physically in District Budgam:-


