The appointment of the Teacher shall be on probation for a period of **Two (02)** years.

The formal appointment order is issued subject to the fulfillment of all the terms and conditions as laid down in the provisional appointment orders reflected above against each. Before implementing the formal order, the Chief Education Officer concerned shall ensure that while verifying the merit position of SSRB as reflected in the provisional appointment order is coinciding with the qualification certificates and if on consequent verification, any variation in the particulars/marks (merit position) is noticed with the qualification certificates in respect of any selectee, the same should be brought into the notice of this Directorate for further instructions/orders.

Seniority of the appointees shall be fixed as per CCA Rules (1956) and satisfactory qualifying of probation period.

This order is issued without prejudice to any writ petition/suit if any pending/sub-judice before the Hon'ble High Court or any other court of law..
