Whereas, the Administrative Department (Education) vide letter No. Edu-I/78/2017, dated. 15/05/2017, has forwarded select list of 20 (twenty) candidates as Lab. Assistants, under open merit category of (District Anantnag=06, Baramulla=04, Bandipora=01, Ganderbal=01, Kupwara=02, Kulgam=03, Pulwama=02, and Shopian=01), issued by the Secretary J&K Service Selection Board Vide No. SSB/Secy/Sel/2017/1258-65, dated 27/01/2017 & No. SSB/Secy/ Sel/2017/1301-07, dated 28/01/2017, under Prime Minister's Special Package for Kashmiri Migrants for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu & Kashmir Migrants (Special Drive Recruitment Rules, 2009, issued under SRO. 412 of 2009, dated 30/12/2009.

Whereas, recommendation in respect of **04** (four) candidates (District Ganderbal=01, Kupwara=01, Kulgam=01 and Pulwama=01), has been kept withheld by SSB for want of certain clarification, leaving 16 (sixteen), candidates for considering their candidature for issuance of provisional appointment orders;

Whereas, this office vide Notification No. DSEK/NT/Mig-Retire/26-31/SF/1097-98, dated 30/06/2017 and No. DSEK/NT/Mig/Retire/26-31/SF/1154-55, dated. 10/07/2017, appeared in Press through information department, dated, 05/07/2017 & 15/07/2017 respectively, directing the selectees to deposit their requisite original as well as self attested certificates/testimonials and undertakings alongwith agreements on the devised format duly attested by 1st Class Magistrate in terms of SRO-412 of 2009, dated 31/12/2009, in this Directorate within (15) days from the date of publishing of the notification in press;

Whereas, In response to the said notifications only 05 (five) selectees, (Anantnag=01, Baramulla=02, Bandipora=01, and Pulwama=01), have deposited their documents/testimonials in the Directorate of School Education Kashmir within the stipulated period;

Now, therefore, Sanction is hereby accorded to the provisional appointment of following five (05) selected candidates, as Laboratory Assistant in District Cadre Anantnag, Baramulla, Bandipora and Pulwama, against the posts created under Prime Minister's Special Package for Kashmiri Migrants, in the pay band of Rs.5200-20200+ grade of Rs.1900/. The full particulars/merit position assigned to them by SSB are indicated against each.

The candidates are required to report to the Chief Education Office Anantnag, Baramulla, Bandipora and Pulwama, within (21) days from the date of issuance of this Order, for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide SRO-400 of 2009 dated 24.12.2009.

The appointees shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer Concerned who shall be required to get these certificates verified/authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic / Qualification certificates viz Degree Marks.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/last attended
- vi. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- viii. Migrant Certificate from competent authority, whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- ix. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his/her character and antecedents is received from Inspector General of Police (CID) J&K and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned Inspector General of Police (CID) J&K, the appointee shall have no right to claim his/her appointment as Lab. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/abinitio.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from concerned District in any case.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case any appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the action of his/her migration, in terms of the agreement executed by each appointee under SRO-412 of 2009.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued form this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/subjudice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
