Grant of Promotion IN-SITU of Higher Standard pay scale.

ORDER NO:- 1067 DSEK OF 2018

DATED:- 9/08/2018

Sanction is hereby accorded to the grant of promotion In-Situ to the Higher Standard pay scale in terms of J&K Civil Services (Higher Standard Pay Scheme) Rules 1996 of J&K Government vide SRO-14 dated. 15.01.1996 in favour of **38** teaching officials (General Line teachers) in the pay band with grade pay from the date as stated against each in the Annexure to this order, However the monetary benefit on account of In-Situ promotion shall be restricted to maximum of three years. in terms of rule 2.43 of Financial Code Vol-I.

In-Situ promotion arrears of Officials shall not be drawn till additional funds for the specific purpose sanctioned by the Competent authority (except retired Officials) for which the concerned DDO's/CEO's shall figure out the provision and submit the requisition accordingly in consolidated manner to the Directorate for adopted SRO-19. Deviation if any shall warrant strict disciplinary action against DDO concerned

The promotion IN-SITU to the Higher Standard Pay Scale in favour of teaching officials, mentioned /released subject to the fulfilment of the following conditions:-

The Chief Education Officer/ Drawing & Disbursing Officer concerned will verify the particulars of each official with his/her original service records before allowing (IN SITU) promotion benefit and he/she shall be personally responsible for correctness of particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of in situ promotion shall not be released and such cases shall be referred to the concerned authority for further orders / clarification.

The employees have completed required spell of 09/18/27 years as the case may be satisfactorily and without any suspension as defined in Rule 4(k) of SRO-14 dated. 15.01.1996;

The employee was not under suspension or contemplated in any charge or charge- sheeted under Classification Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory;

The grant of promotion In Situ shall not change / affect the existing designation / seniority/ duties of the employees.

The benefit of the promotion In-Situ shall not be applicable, if the official who has earlier foregone regular/functional promotion shall forego his functional promotion in future;

On implementing the order, the concerned CEO shall ensure that the employees are holding genuine appointment on regular basis in the department, before endorsing this order to sub-Offices for implementation;

The time bound promotion has been accorded by the DDO/CEO at his own level in favour of any official and none of the officials have received this benefit so far.

If it has been found that the time bound promotion has been sanctioned in favour of RRT by virtue of this order, the same should not be given effect as the time bound sanction of RRT will be considered separately.

In case of grant of HSPS, their pay fixation and pay/pension arrears admissible from the date the HSPS as mentioned shall be regulated strictly in accordance to the provisions laid down in SRO 93 dated. 15.04.2009 and Govt. Order No. 18 E and Govt Order No.08 F dated.18.01.2011 read with SRO-42 dated 02/02/2011, Govt Order No.238 F of 2011 dated 20.01.2011 and SRO 193 dated 24.04.2018.

The DDO concerned shall allow the benefit of In-Situ promotion in respect of erstwhile FAT /Migrant teachers only on production of their service bio data with original documents viz; service book, appointment order, qualification order and regularization order of the competent authority.

The officials in whose favour In Situ promotion has been released have been appointed / promoted to the present status by the competent authority
