Whereas, the Administrative Department vide letter No. Edu-I/443/2016, dated. 04/01/2017, has forwarded select list of 10 (ten) Junior Assistants for District Anantnag (OM=01, RBA=02), District Bandipora (OM=04, RBA=01) and District Ganderbal (RBA=02), issued by the Service Selection Board Vide No.SSB/Secy/Sel/2016/19550-55, dated 31/08/2016, No. SSB/Secy/Sel/2016/19536-42 dated. 31/08/2016 and No. SSB/Secy/Sel/2016/19529-35, dated. 31/08/2016;

Whereas, this office vide Notification No. DSEK/NT/SSB/JA/529/2017/All/288, dated.04/02/2017, appeared in Press through information department on dated 08/02/2017, directing the selectees to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within (10) days from the date of publication of the notification in the press;

Whereas, In response to the said notifications 05 (five) selected candidates, (Anantnag RBA=01), (Bandipora OM=03, RBA=01) have deposited their documents/testimonials in this Directorate for issuing their appointment orders;

Whereas, appointment orders were issued in respect of those candidates who have deposited their documents in this Directorate, vide order No. 463-DSEK Of 2017, dated 19/05/2017, No.502-DSEK of 2017, Dated 31/05/2017 and No. 655-DSEK of 2017, dated 19/06/2017, respectively;

Whereas, the candidates, who have failed to deposit their documents in the Directorate despite given final opportunity to deposit the same within (7) days vide notification No. DSEK/NT/SSRB/529/ 2017/617-18, dated. 03/04/2017 appeared in press on 10/04/2017, have again failed to do so;

Whereas, due to non-submission of documents/certificates by some candidates, the matter has been take-up with the Administrative Department for authorisation of operating of wait list, vide this office letter No. DSEK/NT/SSB/529/2017/1055, dated.22/06/2017;

Whereas, the Administrative Department vide letter NO. Edu-I/443/2016, dated 25/07/2017, has conveyed approval for operating waiting list against the slots which became available due to non-depositing of documents by the selected candidates;

Whereas, vide this office notification No. DSEK/NT/SSB/JA/529/2017/1232-33, dated.07/08/2017, the candidates appearing in waiting list, (Anantnag OM=01) and (Bandipora OM=01) were asked to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within (07) days from the date of publishing of the notification in press;

Whereas, in response to the said Notification, the said selected two candidates under wait list have deposited their documents/testimonials/undertaking in the Directorate for processing of issuance of their appointment orders.

Now, therefore, sanction is hereby accorded to the provisional appointment of following two candidates as Junior Assistants in District cadre Anantnag and Bandipora, in the pay band of Rs.5200-20200+ grade of Rs.1900/-. The full particulars/ merit points assigned by SSB are indicated against their name.

The candidates are required to report to the Chief Education Office **Anantnag, Bandipora** within **(21)** days from the date of issuance of this Order, for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009 dated 24.12.2009.**

The appointees shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Concerned** who shall be required to get these certificates verified/authentication from the concerned issuing authorities

- ❖ Character and antecedents certificate from Additional Director General of Police (CID)
- ❖ Academic / Qualification certificates viz Degree Marks
- ❖ Permanent resident certificate
- ❖ Age and health certificate
- ❖ Discharge certificate from the Institution attending/ last attended
- ❖ Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee
- ❖ Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- ❖ Total marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his/her character and antecedents is received from **Inspector General of Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his/her appointment as **Jr. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/abinitio.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from concerned **District** in any case.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through **concerned** Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
