Whereas, the Administrative Department vide letter No. Edu-I/124/2016, dated.29/04/2016, has forwarded select list of **07 (Seven)** Junior Assistants, (**OM=05 & RBA=02**), of District **Budgam**, issued by the Secretary J&K services Selection Board Jammu vide No. SSB/Secy/Sel/2016/3584-90 dated. 02/03/2016.

Whereas, withhold recommendation in respect of two selectees namely Mehraj-Ul Din and Shakeela Akhter appearing at S.No 01 & 02, respectively under RBA category , were released by the SSB vide No. SSB/Sel/Secy/2016/8466-68 dated. 07/04/2016, conveyed by Administrative Department vide No. Edu-I/124/2016, dated.29/04/2016.

Whereas, this office vide notification No. DSEK/NT/SSB/JA/516/2016/ 379-M/Bud/1059-60, dated.27/05/2016, appeared in Press through information department dated. 02/06/2016, directed the selectees to deposit the requisite original as well as self attested certificates / testimonials in this Directorate within **10 days** from the date of publishing of the notification in the press.

Whereas, In response to the said notification only **06 (Six)** selected candidates, (**OM=04 & RBA=02**), have deposited their documents/ testimonials in the Directorate for issuing their appointment orders.

Whereas, **01 (One)** candidate namely Sheikh Sajad Kousar S/O. Gulzar Ahmad Sheikh R/O. New Colony Khanihama Magam, Budgam, appearing at S.No **05**, under **OM** category of the select list, who has not deposited his documents to this Directorate within the stipulated time, will be given one more opportunity to deposit the same within the reasonable time.

The candidate is required to report to the Chief Education Office **Budgam** within **10 days** from the date of issuance of this Order, for further posting against the available vacancies in needy institution, on his/her own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as per SRO-400 of 2009 dated.24.12.2009.

The appointment of the candidate shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Budgam** who shall be required to get these certificates verified-/ authenticated from the concerned issuing authorities.

- ❖ Character and antecedents certificate from Additional Director General of Police (CID).
- ❖ Qualification certificates.
- ❖ Permanent resident certificate
- ❖ Age and health certificate
- ❖ Discharge certificate from the Institution attending/ last attended
- ❖ Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- ❖ Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- ❖ Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his/her character and antecedents is received from the concerned Additional Director General of Police (CID) J&K. and genuineness/ verification report for qualification certificates /Technical Certificate /Marks Certificates and category certificates (if any) from the issuing authority.
- She shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned Additional Director General of Police (CID) J&K , the appointee shall have no right to claim his/her appointment as Jr. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
- The Chief Education Officer, **Budgam** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- She shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Budgam** in any case, and in case, at any stage it emerges that the certificates/ any relevant document furnished/ produced by the selectee is fake / fictitious, the appointment order shall be cancelled abinitio and criminal proceeding shall be initiated against the candidate

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned CEO duly counter-signed, confirmation of provisional appointment order will be issued accordingly. No salary be drawn in favour of the candidate till such order is issued from this Directorate.

The inter-se seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

The appointment of the candidate shall be subject to outcome of any writ petition(s)/, if any, pending in ay court of competent jurisdiction.
