Whereas, the Administrative Department vide letter No. Edu-I/186/2017 dated 10.07.2017 forwarded the selection list of 40 candidates (out of 52) selected as Teachers in District Cadre Budgam in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No's.013) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/2668-74 dated: 08.03.2017;

Whereas, among other selection/recommendation in respect of 07 candidates was kept withheld by the JKSSB and was subsequently released vide letter dated 18.03.2020 conveyed by Administrative Department vide letter No. Edu-I/908/2017-I dated 22.07.2020;

Whereas, recommendation in respect of Shri Rakesh Raina S/o Roshan Lal Raina and Simmi Tickoo W/o Rajinder Kumar Bhan figuring at S.No. 01/OM/waiting earlier (now 41/OM) and S.No. 06/OM/waiting earlier (now 46/OM) was also released vide above referred communication, however, appointment order was not issued in their favour as their candidature was earlier cancelled by the JKSSB vide Order No. 464-SSB of 2018 dated 25.10.2018;

Whereas, the matter was taken up with the Administrative Department vide this office letter No. Estt-III/B-Trs/9698 dated 14.09.2020 followed by letter No. DSEK/Estt-III/B-Trs/9770 dated 22.09.2020 for obtaining necessary clarification;

Whereas, the Administrative Department vide letter No. Edu-I/908/2017 dated 25.02.2021 has forwarded JKSSB's communication No. SSB/Sel/Secy/28/17/K/897-99 dated 02.02.2021 wherein it has been conveyed to take further appropriate action in light of JKSSB's letter dated 18.03.2020 whereunder among others, the recommendation of the duo was also released;

Now, therefore, pursuant to selection/ releasing of recommendations by JKSSB as conveyed by the Administrative Department vide aforementioned communication, sanction is hereby accorded to the provisional appointment of **Rakesh Raina S/o Roshan Lal Raina and Simmi Tickoo W/o Rajinder Kumar Bhan** whose particulars are reflected below as "Teacher" in District Cadre **Budgam** in pursuance to SSB's advertisement Notice No. 01 of 2012 dated 19.07.2012 item No. 013 against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants in the Pay Scale of **Rs.5200-20200** with grade pay of **Rs.2800 and 2400 (Pre-revised)** for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009:

The provisional appointees shall report to the Chief Education Officer Budgam within a period of **21 days** from the date of issuance of this appointment order for seeking further posting orders on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

**In case the candidate fails to join within a period of 21 days from the date of issuance of the appointment order he/she shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice** in light of the Circular instructions issued by the GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, Budgam shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointees shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the District under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement to be executed by the appointee under SRO-412 before Chief Education Officer, Budgam.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
