Sanction is hereby accorded to the compassionate appointment of Mtr. Rubina Rasool (10+2) D/o Ghulam Rasool Paray & Saja Bagum W/o Late Aijaz Ahmad Bhat, (deceased Class IV, HSS B.K.Pora) R/o Paharoo, Budgam as Class IV (Lab. Bearer) in the pay scale of Rs. 4440-7440 with grade pay of Rs 1300/= against the available post in HSS Khanda. The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production/verification of the following certificates in original:

1. Age and Health certificate.
2. Educational qualification certificate (from recognized Board/University)
3. Character/ Antecedents certificate.
4. Date of Birth certificate.
5. Permanent Resident certificate.
6. No Loan certificates.
7. Affidavit to the effect that in case of adverse report from CID she will not claim for the post/salary.
8. Affidavit duly Sworn before Judicial Magistrate to the effect that in the event of her failure to look after the deceased family her appointment shall be cancelled.
9. If on verification , the certificates produced by the appointees are proved fake or forged, the appointment shall be cancelled abinitio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence of verification of her character/antecedents from CID. However, her pay shall not be drawn and paid till the verification of her character / antecedents is received from the CID. In case of adverse report from the CID, the order will be deemed to have been cancelled & will have no claim for salary for the period she worked, and an undertaking to this effect be also obtained from her for record and reference.


