Whereas, the Divisional Departmental Promotion Committee meeting was held on 06/01/2018, among other agenda points, the matter regarding promotion of eligible Library Assistants on the available Junior Librarian posts was placed before the committee as Agenda item No: 12.

Whereas, the DPC agreed to, the promotion of 02 (two) Lib. Assistants, in District Budgam according to the strict seniority, subject to the obtaining of fresh vigilance clearance from GAD (Vigilance).

Whereas, Mr. Mohd. Shafi Dar Lib. Assistant, figuring at S.No.02 in the DPC approved list (in whose favour vigilance clearance was received from GAD Vigilance) was promoted on 30/07/2018 vide DSEK order No: 992-DSEK of 2018 dated 30/07/2018.

Whereas, the Administrative Department has conveyed fresh vigilance clearance issued from GAD (Vigilance) vide O.M. No: GAD (Vig) 14-NOC/2018-Edu dated 16/07/2018 in favour Mtr. Nusrat Jabeen, Lib. Assistant HS Repora, figuring at S.No.03 in the DPC approved list.

Now, therefore, as approved by the Divisional Departmental Promotion Committee and cleared by the GAD (Vigilance), sanction is hereby accorded to the promotion of Mtr. Nusrat Jabeen Lib. Assistant, whose particulars are given below, as Junior Librarian in the pay band of Rs.5200-20200 with grade pay of Rs.2400/- (Pre-Revised) in District Cadre Budgam with effect from 30/07/18 notionally and with monetary benefit from the date of joining on the higher post.

The promotion of Lib. Assistant to the post of Junior Librarian shall be subject to fulfilment of the following conditions:-

1. If the Lib. Assistant as named above in the promotion order is, on subsequent verification, found not eligible for such promotion, this order will not confer any right on her and her promotion on the higher post (made hereby) shall be liable to be rescinded in that case. It will be **personal responsibility** of the Chief Education officer/Drawing and Disbursing Officer to verify particulars of the promotee with reference to her original service records and ensure that the date of 1st appointment as Lib. Assistant as well as other particulars recorded against her (here in above in this order) are correct. Variation if any found should be brought to the notice of this Directorate for further orders. In that case the Lib. Assistant shall not be relieved for her promotion on the higher post.


2. The promotee must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of promotion shall not be allowed in case a promotee be under suspension or in case the departmental proceedings may be pending against her or her work and conduct may not be satisfactory.
3. Superior claim vis-à-vis inter-se-placement of the promotee for re-determination of seniority in the cadre of Lib. Assistant, if any shall be submitted to this Directorate within a period of one month through proper channel.
4. The promotion shall be without pre-judice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble High Court or any other court and other orders, if any passed by the competent authority which may not be immediately within the knowledge of this Directorate.
5. The Chief Education officer must ensure that there is nothing adverse against the promotee from VOK/Crime/Police.
6. The promotee is required to report to Chief Education Officer Budgam for further posting within twenty one days from the date of issuance of promotion/adjustment order, failing which, the order shall automatically stand rescinded ab-initio in her favour without issuing formal cancellation orders.
