Whereas, the Divisional Departmental Promotion Committee meeting was held on 06/01/2018, among other agenda points, the matter regarding confirmation/promotion of I/c Head Assistants (Senior Assistants) who have crossed 50 years age and are eligible for promotion as Head Assistants under SRO 272 of 2008 dated 19/09/2008, was placed before the committee as agenda item No.22.

Whereas, the DPC agreed to, the confirmation/promotion of 06 (six) I/c Head Assistants (Senior Assistants) subject to the condition of providing fresh vigilance clearance from GAD (Vigilance).


Whereas, Mtr. Dilafroza and Mr. Khurshid Ahmad Chesti, I/c Head Assistants figuring at S.No. 02 and 03 in the approved list (in whose favour vigilance clearance was received from GAD Vigilance) were confirmed/promoted as Head Assistants prospectively vide DSEK order No: 468 DSEK of 2018 dated 30/03/2018.

Whereas, Administrative Department has conveyed fresh vigilance clearance, issued from GAD (Vigilance), vide letter No: GAD (Vig)14-NOC/2017-Edu dated: 30/08/2017 and No: GAD(Vig)14-NOC/2018-Edu dated 04/06/2018 in favour of Mtr. Zareefa Akhter, I/c Head Assistant, ZEO Mattan and Mtr. Naseema Sidiq Ex-I/c Head Assistant, ZEO Anantnag respectively.


