Whereas, pursuant to the approval of General Administration Department conveyed vide O.M.No. GDC-106/CM/2018 Dated 06/07/2018, the Administrative Department vide G.O.No. 853-Edu of 2018 Dated 07/09/2018 issued under No. Edu/L/K/188/2015 Dated:- 07/09/2018, accorded sanction to the appointment of 06 (Six) candidates (petitioners) as Teachers in the pay scale of Rs 5200-20200 +GP 2800 in District cadre Budgam. notionally from the date private respondent No's. 05 and 06 in the petition were appointed vide DSEK Order No. 503-DSEK of 1999 Dated:- 31.03.1999 on the recommendations made by the Services Selection Board in pursuance of Advertisement Notice No. 03 of 1996 dated 24.12.1996 and No. 08 of 1997 dated 09.09.1997 and regulary from the date of issuance of appointment order, after grant of relaxation of upper age limit as indicated against each;

Whereas, the Administrative Department in the endorsement of the said Order desired to issue appointment orders in favour of the candidates strictly as per the approval conveyed after fulfilling all the codal formalities;

Whereas, after perusal of documents/certificates, it has been observed that the Date of Birth of the candidate figuring at S.No. 01 in the said Order namely Mr Shakeel Ahmad Shakeel is recorded as **15.02.1973**, while as **15.02.1963** has been recorded in the Date of Birth column of the said Order for which clarification is being sought from the Administrative Department, separately;

Now, therefore, in pursuance of approval of General Administration Department and the orders of the Administrative Department, sanction is hereby accorded to the provisional appointment of following **Five (05) candidates (petitioners) as Teacher**, in relaxation of upper age limits as indicated against each below in **District Cadre Budgam** in the pay scale of Rs.5200-20200 with grade pay of Rs.2800, on probation for a period of two years:-

The candidates are required to report to the Chief Education Officer, Budgam within **Twenty-one (21) days** from the date of issuance of this order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned issuing authorities:-

- Qualification certificates viz Degree/Marks.
- Permanent resident certificates.
- Age and health certificates.
- Discharge certificate from the Institution attending/ last attended.

- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Character antecedents report from CID, J&K

The provisional appointment shall be subject to the following conditions:-

- A. The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B. The verification of all documents/ qualification certificates from the concerned issuing authority.

The Confirmatin to the provisional appointment order of the candidates shall be issued by this Directorate only after receiving of verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer.

The salary of the appointees shall be drawn by the DDO concerned only after issuance of formal/confirmation of provisional appointment orders, to be issued by this Directorate.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before any Hon'ble Court which is not immediately within the knowledge of this Directorate.
