Sub:- Select list of the candidates for the post of teacher (Education Department) District Cadre Ganderbal in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 284, 456 & 417) respectively under fixed salary mode and **operation of wait list thereof.**

Whereas, the Administrative Department vide letter No. Edu-I/145/2014 Dated 07/07/2014 forwarded the list of 73 candidates selected as Teachers for District cadre Ganderbal, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/4443-49 dated 03.06.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 issued the guidelines to issue the provisional appointment orders in favour of the candidates for the post of teachers selected by the SSRB after taking the undertaking from the appointee with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the Judicial Magistrate.

Whereas vide this office Notification No. DSEK/Estt-III/B-Trs./34/2014/Sel/Gbl/ 3571-72 dated: 14/08/2014 and No. DSEK/Estt-III/B-Trs./34/2014/Sel-Gbl/Notf/ 3831-32 dated: 17/10/2014 etc. the selectees were asked to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, many candidates under various categories detailed below have not submitted their undertakings/not joined in the concerned CEO's office as intimated vide by Chief Education Officer Ganderbal vide No. CEO/Gbl/Estt-I/ 6499 dated 21.11.2014;

Whereas, vide this office letter No. DSEK/III/B-Trs/39/2014/Sel-Kup/PF/4540-41 dated 02.03.2015 the matter was taken up with the Administrative Department for conveying necessary instructions;

Whereas, in response to the aforementioned communication dated 02.03.2015, the Administrative Department vide letter No. Edu-1/288/2014, dated 30.03.2015 has conveyed instructions for operating wait list against the slots which became available due to non-joining/non-depositing of undertakings of selectees;

Whereas, in light of above instructions of the Administrative Department, the candidates who were in queue in the selection (wait list) of SSB District Cadre Ganderbal (Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 284, 456 & 417) and were making place in the selection zone against the resultant vacancies, were asked to deposit their undertakings duly attested by the 1st Class Judicial Magistrate on the devised format in the Directorate of School Education Kashmir and also deposit their original qualification and category certificates before the Chief Education Officer Ganderbal for seeking verification/authentication of these certificates from the concerned issuing authorities vide this office notification No. DSEK/Estt/III/B-Trs/34/2014/Sel-Gbl/4926-29 dated 16.04.2015;

Whereas in response to the said notification dated 16.04.2015, **Four (04 out of 05)** candidates submitted their undertakings (leaving **01** candidates who failed to do so), duly attested by the 1st Class Judicial Magistrate on the devised format in the Directorate of School Education Kashmir for further appropriate action;

Now, therefore, sanction is hereby accorded to the provisional appointment of **(01/OM, 02/RBA, 01/SC = 04) Four** candidates as Teachers in District Cadre Ganderbal against the available slots in various categories/Items as per the Annexure. The candidate is required to report to the Chief Education Officer, Ganderbal by or before **7th May, 2015** for further posting.

The Chief Education Officer Ganderbal shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the above selectee shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.






