Whereas, the Administrative Department vide letter No. Edu-1/692/2015, dated.26/02/2016, has forwarded select list of **12 (Twelve)** Junior Assistants of District **Srinagar**, under **OM** Category issued by the Secretary J&K services Selection Board Jammu vide No. SSB/Secy/Sel/2015/16567-73 dated.22/12/2015.

Whereas, this office vide notification No. DSEK/NT/SSB/JA/509/2016/Bd/Sgr/Kul/Gbl/576-77, dated.14/03/2016, directed the selectees to deposit the requisite original as well as self attested certificates / testimonials in this Directorate within **10 days** from the date of publishing of the notification in the press.

Whereas, In response to the said notification only **(03)** selected candidates have deposited their documents/ testimonials in the Directorate for issuing their appointment orders.

- Satisfactory report about his character and antecedents is received from the concerned Additional Director General of Police (CID) J&K. and genuineness/ verification report for qualification certificates /Technical Certificate /Marks Certificates and category certificates (if any) from the issuing authority.
- He shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned Additional Director General of Police (CID) J&K , the appointee shall have no right to claim his appointment as Jr. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
