Subject:- Select list of candidates for the post of Teacher District Cadre Pulwama (Item No. 434) advertised vide notification No. 06 of 2013 under SWP No. 2074/2014 titled Aijaz Ashraf V/s State and others and issuance of provisional appointment thereof.

ORDER NO. 1287 DSEK OF 2017

Whereas, the Administrative Department vide letter No. Edu-I/347/2014 dated: 24.10.2014 forwarded the list of 279 candidates who have been selected as teachers in District Cadre Pulwama in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 315, 466 & 434) conveyed by Secretary Service Selection Board J&K Srinagar vide communication No. SSB/Sel/Secy/014/8971-77 dated: 18/10/2014.

Whereas, aggrieved due to non-selection, one, **Mr. Aijaz Ashraf S/o Mohammad Ashraf Bhat R/o Gabarpora Hawal Pulwama** filed a writ petition in the Hon'ble High Court under SWP No. 2074/2014 titled **Aijaz Ashraf V/s State and others**, wherein he made the plea that his B.Ed merit has not been considered by the SSB against Item No. 434 (Notification 06 of 2013) on the ground that he has not bubbled B.Ed in the OMR application form;

Whereas, the Hon'ble Court on 30.10.2014 passed a direction in the aforementioned writ petition and directed as under:-

**In the meanwhile, pending decision in the application, respondents shall reserve one post of teacher out of the selection made in terms of advertisement notification No. 06 of 2013"**

Whereas, in compliance to the Hon'ble Court order dated 30.12.2014 one post figuring at tail end of the selection list under item No. 434 Advertisement notice No. 06 of 2013 dated 10.05.2013 against OM Category was not given effect;

Whereas, the Hon'ble Court vide Order dated 31.07.2015 disposed of the case with the direction as under :-

**"Heard leaned counsel for the parties, this case is covered by the judgement of the Court passed in SWP No. 2029/2014 1<sup>st</sup> June, 2014. Copy of the judgement is taken on record. This writ petition is disposed of in terms of the aforesaid court judgement. Respondents to implement the aforesaid court judgement in the case in hand also."**

Whereas, in compliance to the Hon'ble Court judgement dated 31.07.2015 the J&K Services Selection Board, Srinagar vide Order No. 532-SSB of 2015 dated 10.12.2015, recommended the petitioner for the post of Teacher against Item No. 434 (Notf. 06 of 2013);

Whereas, aggrieved by the Single Bench Order dated 31.07.2015, one Tariq Ahmad Dar figuring at S.No. 4/Wait against item No. 434 (Notification 06 of 2013), filed LPA No. 209/2016 titled Tariq Ahmad Dar V/s Aijaz Ashraf and others, which stand dismissed by the Hon'ble Court vide order dated 28.07.2017. The operative part of which reads as under:-

**"On 12.07.2017 none appeared for the appellant. Today also matter was taken up and none appeared. It was passed over twice but even then none appears for the appellant which suggest lack of interest to prosecute. Dismissed for want of prosecution alongwith connected MP. Interim direction, if any, shall stand vacated";**

Whereas, the matter was taken up with the Administrative Department vide this office letter No. DSEK/Est/III/66739/Lit/264/2014 dated 02.11.2015 and in response to the said communication the Administrative Department vide letter No. Edu/Legal/KJ97/2014 dated 14.08.2017 has forwarded the copy of SSB's Order No. 532-SSB of 2015 dated 10.12.2015 and has requested to take further appropriate action in the matter;

Whereas, in view of the aforementioned circumstances, a notification bearing No. DSEK/Estt/III/B-Trs/6796-800 dated 22.09.2017, was issued in respect of the petitioner (Aijaz Ashraf) for deposition of documents within a period of Seven days.

Whereas, in response to the said notification dated 22.09.2017, the said candidate furnished his papers viz. all qualification Certificates alongwith undertaking from the 1<sup>st</sup> Class Magistrate devised for the purpose within the stipulated time period;

Now, therefore, in compliance to the orders of the Hon'ble High Court and recommendations of the SSB/Administrative Department, sanction is hereby accorded to the provisional appointment of **Aijaz Ashraf S/o Mohammad Ashraf Bhat R/o Gabarpora Hawal Pulwama** (whose full particulars are reproduced below) as **Teacher in District Cadre Pulwama** in the pay scale of Rs.5200-20200 with grade pay of Rs. 2800, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Pulwama within **Ten (10) days** from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned agencies.

The Chief Education Officer, Pulwama shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn.


The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
