Whereas, this office has received the compassionate appointment case of Mtr. Asima wani W/o Late Manzoor Ahmad Bhat R/o Kremshore Khansahib District Budgam vide Chief Education Officer, Budgam's letter No. CEOR/NT/2019/3791 dated 07-05-2019 for consideration of his/her appointment under SRO-43 of 1994.

Whereas, deceased namely Late Manzoor Ahmad Bhat was working as Lab. Assistant at BHSS Khansahib, Budgam on regular establishment who died in harness on 24.08.2018 as per the death certificate issued by Registrar of Births and Deaths vide registration No. 223 Dated: 28.08.2018.

Whereas, as per dependence certificate issued by Sub. Divisional Magistrate Khansahib vide No. SDM/KS/2019/93 dated: 14.01.2019 the deceased has left behind the following dependents:

Whereas, dependents above have given the undertaking/ affidavits duly attested by Munsiff Judicial Magistrate Ist Class Budgam to the effect that they will have no objection if dependent No. 03 (Asima wani W/O: Late Manzoor Ahmad Bhat R/o Kremshore Khansahib Budgam) is appointed in terms of SRO-43 on compassionate grounds.

Whereas, Asima Wani W/o: Late Manzoor Ahmad Bhat R/o: Kremshore Khansahib Budgam dependent No. 03 has also submitted an affidavit duly attested by the Munsiff Judicial Magistrate 1st Class Budgam to the effect that he/she will look after the other dependents of deceased on availing the benefit of the appointment under SRO-43.

Whereas, the case was placed before the committee constituted vide this office Order No: 1172 of 2017 Dated: 16.02.2017 for consideration.

Whereas, this Directorate has published the particulars of the beneficiary in the print media, vide this office letter No. DSEK/Estt/SRO/43/2019/8066 dated: 26/11/2019 for inviting objections, if any for considering the appointment of beneficiary in terms of SRO-43.

Whereas, the Chief education officer Budgam vide his letter No. CEOR/Estt/NT/2019/22599 dated: 17.12.2019 has reported that nobody has filed his objection for

considering the appointment of the beneficiary in terms of SRO-43 on compassionate grounds within stipulated period of seven (07) days.

Now, therefore, in face of the recommendations of the committee, sanction is hereby accorded to the appointment of Asima Wani W/O: Late Manzoor Ahmad Bhat R/o: Kremshore Khansahib as Class-IV (Lab. Bearer) GHSS Chararisharief District Budgam on regular temporary basis on compassionate grounds in terms of SRO-43 for a period of 02 years on probation, (due to the death of his/her Husband) in the pay level of 14800-47100 SL-I against available vacancy in Budgam District as identified by Chief Education Officer Budgam.

The applicant shall submit joining report in the office of Chief Education Officer, Budgam within a period of 21 days subject to the following conditions and production of required certificates:

- i. Academic/Qualification/DOB Certificate.
 - ii. Physical Fitness Certificate.
 - iii. Permanent Resident Certificate..
 - iv. Certificate from concerned authorities to the effect that no loan under self employment scheme has been taken by the concerned candidate
 - v. Any other relevant certificate as required under rules.
 - vi. Category certificate, if any.
- a. The concerned shall get the certificates/documents verified from the issuing authority.
 - b. The appointee shall be on probation for a period of 02 years.
 - c. The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report about his/her character/antecedents is received from Inspector General of Police, CID/concerned agencies to whom a reference shall be made by this department.
 - d. If, on verification, the certificates/documents produced are proved fake or forged or the verification report about character and antecedents is received as un-satisfactory the appointment shall be deemed to be cancelled ab-initio.
 - e. That the appointee will look after the family left behind by the deceased as per affidavit submitted by him/her. In case any thing adverse is reported and proved the appointment shall be cancelled, ab-initio.


