Subject:- Production of fake/fabricated 12th Class certificate-termination of services thereof.

Order No. 1365 DSEK of 2018
Dated 13 / 11 / 2018

Whereas, vide Order No. 1989 of 2003 Dated 15/03/2003 issued by the Zonal Education Officer, Ganderbal, Mtr. Hajra Banoo W/o Gulzar Ahmad Sheikh R/o Saderbagh, Zone Ganderbal was engaged as ReT Teacher in Boys Middle School, Serch, Chodribagh, Zone Ganderbal on the basis of 10+2 qualification certificate issued by the J&K BoSE Srinagar under examination Roll No. 903479 Annual-1994 showing marks 423/600 in the Marks Certificate;

Whereas, the services of the said ReT Teacher were also regularized vide this Office Order No. 549-DSEK of 2008 Dated 22/03/2008;

Whereas, the said RRT Teacher was subsequently deputed to DIET Ganderbal for undergoing D.E.Ed. training course during the Session 2015-16;

Whereas, the Principal, DIET Ganderbal sought verification report from the J&K BoSE with regard to the genuineness of qualification certificates of 10th and 12th Classes of the said RRT Teacher respectively;

Whereas, Joint Secretary (Verification) J&K Board of School Education vide his letter No. F(JS-Ver)B/KD/2016G-1688 Dated 06/12/2016 had conveyed the genuineness of 10th Class certificate;

Whereas, Joint Secretary (Verification) J&K Board of School Education vide communication No. F(JS-Ver)B/KD/2017/G-402 Dated 20/09/2017 informed that 12th Class certificate which was produced by the said RRT Teacher does not exist in their records, and as such declared the certificate as absolutely fake and fabricated;

Whereas, Zonal Education Officer, Ganderbal had thereafter issued a show cause notice Dated 10/10/2017 asking the delinquent official to explain her



position but she failed to reply within the stipulated time frame. However, she was given an additional period of three days, for submitting her reply which was received on **03/11/2017**, wherein she denied the allegations and requested for re-verification of the qualification certificate;

Whereas, accordingly the Chief Education Officer, Ganderbal sought re-verification of 12th Class certificate from J&K Board of School Education vide letter No. CEO/Gbl./15031 Dated 17/11/2017 from concerned quarters;

Whereas, in response the Joint Secretary (Verification) J&K Board of School Education vide his letter No. F(Vs-Ver)B/KD/2017Q-739 Dated 23/12/2017 reiterated the earlier position and reported that the verification report bearing No. C027 of 02/08/2002 in respect of 12th Class certificate showing to have been issued by J&K BoSE, has not been actually issued by the J&K BoSE, hence be treated as absolutely fake and fabricated;

Whereas, pending enquiry, the delinquent official was placed under suspension vide this Office Order No. 1685-DSEK of 2017 Dated 30/12/2017 and attached with the Office of Chief Education Officer, Ganderbal and Joint Director (EE) Directorate of School Education, Kashmir was nominated as Inquiry Officer vide Order No. 304-DSEK of 2018 Dated 09/03/2018 to conduct an in-depth inquiry into the matter;

Whereas, the Joint Director (EE) has also got the said documents verified from the J&K Board of School Education and the Joint Secretary (Verification) J&K Board of School Education vide his letter No. F(JS-Ver)B/KD/2017/A-2065 Dated 28/06/2018 informed that the document does not exist in the Board records and may be treated as absolutely fake and fabricated;

Whereas, prima-facie, it is evident that the delinquent official has deceived the Department and obtained appointment as ReT on the basis of a fake/forged marks certificate, which tanta-mounts to the office of perjury, involving panel consequences;

Whereas, the settled proposition of law is that fraud un-revels everything and if a person has played fraud in obtaining an appointment, he/she should not be allowed to get the benefits thereof, as the foundation of appointment collapses;

Handwritten signature and initials, possibly 'A' and 'Gx', in black ink.

Whereas, pursuant to this Directorate No. DSEK/Estt-III/B-Trs./Comp/12/2017/Gbl/2947-48 Dated 14/08/2018, the final show cause notice was served upon the said delinquent RRT Teacher Boys Middle School, Serch Chodribagh, Zone Ganderbal;

Whereas, the said delinquent RRT Teacher Boys Middle School, Serch, Chodribagh Zone Ganderbal has come-up with the reply to charge sheet, and has denied the allegations with regard to the 12th Class certificate, but stated that the said document stand already verified by the Department way back in the year 2002 under No. C-27, though the J&K BoSE Srinagar had already reported that no such report was issued under the reference cited above.


