Whereas, the Administrative Department vide letter No. **Edu-I/332/2017 dated 10.07.2017** forwarded the list of 08 candidates selected as Teachers for District Cadre Kupwara pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Secy/Sel/2017/5270-76 dated 09.06.2017 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

**The salary in favour of the selected candidates is only drawn:-**

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of Birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas vide this office Notification No. DSEK/Est/III/B-Trs/6646-49 dated 07.09.2017, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, in light of above instructions of the Administrative Department **only One (01)** candidates furnished her undertaking on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in response to the said notification dated 07.09.2017;

Now, therefore, sanction is hereby accorded to the provisional appointment of **One (01)** candidate namely Kavita Rani (Detailed below) as Teacher in District Cadre Kupwara against the available slot in in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, **Kupwara** within **Ten (10)** days from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned issuing authorities:

The Chief Education Officer, Kupwara shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall be on probation initially for a period of Two years.


