Whereas, the Administrative Department vide aforementioned communications forwarded the selection list of **Forty-nine (49)** candidates selected as Teachers, under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders after fulfilling of all formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to their selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1250-57 dated 27.01.2017 and and No. SSB/Secy/Sel/2017/11258-65 dated: 06.11.2017 against Notification No. 01 of 2012 dated 19.07.2012;

Whereas, this office issued notification to these selectees to deposit their testimonials and undertakings alongwith agreements on the devised format (duly attested) by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009, within a specific period of time vide this office No. DSEK/Estt/III/B-Trs/PMP/017/Sel/6055-58 dated 06.07.2017;

Whereas, Five (05) candidates failed to deposit requisite documents despite issuance of various notifications through Information Department and also placed on the official website of this Directorate and even final opportunity was provided to these non-joining aspirants vide this office No. DSEK/Estt/III/B-Trs/PMP/017/1213-20 dated 12.04.2018;

Whereas, the issue was taken up with the Administrative Department vide this office communication No. Estt-III/B-Trs/636 dated 26.02.2018 for obtaining necessary instructions/orders in respect of these non-joining aspirants;

Whereas, the Administrative Department vide communication No. Edu-I/908/2017 dated 13.08.2018, conveyed instructions to issue formal appointment order in respect of all such Five non-joining candidates with the direction to join the Department within a prescribed period of **21 days**, failing which their appointment shall be cancelled abinitio and the resultant slots shall be filled from the Waiting list;

Whereas, pursuant to the instructions of the Administrative Department all the Five non-joining candidates were provisionally appointed vide this office Order No. 1136-DSEK of 2018 dated 01.09.2018 and were directed to report within 21 days from the date of issuance of this Order with a condition that their appointment shall be cancelled abinitio without serving of any further notice;

Whereas, in pursuance to the above provisional appointment order dated 01.09.2018, only One candidate joined against the post, leaving **Four (04)** candidates who failed to do so, and accordingly their provisional appointment was cancelled vide this office Order No. 1329-DSEK of 2018 dated 29.10.2018;

Whereas, due to non-joining of these Four candidates, Four slots became available for operation of waiting list, however, recommendation in respect of Two candidates figuring at S.No. 3 & 4 in the Waiting list has been kept withheld by the SSB, as such their appointment orders could not be issued till their recommendations is released by the competent authority;

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/PMP/017/3482-30 dated 30.10.2018, the two candidates against whom recommendations were not kept withheld by the SSB were informed to furnish their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009, within a period of **Ten days** from the date of publication of the notification;

Whereas, in response to the above notification dated 08/09/2018, both the candidates deposited the requisite papers in the Directorate of School Education Kashmir within the stipulated time period;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two (02) candidates** whose full particulars are reflected below as Teachers in **District Cadre Kulgam** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 (Pre-revised) for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate are required to report to the Chief Education Officer, **Kulgam** within **Twenty-one (21) days** from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities;

The provisional appointment shall be subject to the following conditions:-

- The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to who a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The **formal appointment orders** of the candidates shall be issued only after receiving verification reports viz. date of birth/marks certificates/category/Migration/PRC certificate and other (if any) from the issuing authority through concerned Chief Education Officer and **no salary till issuance of such orders shall be drawn.**

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and **shall not be eligible for transfer outside the district under any circumstances**. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand **terminated** without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointees shall be fixed at the places on the posts of their first appointment in that particular grade/service. The provisional appointee shall be on probation initially for a period of **Two years**.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
