  - ix. That the candidates (**ReTs**) if appointed during winter breaks be dealt in terms of circular instructions issued by this Directorate vide No. Estt-III/B-Trs/ReT/Misc/99/28/1828 Dated 08-06-2010.
  - x. As a matter of policy and consistent with the imperatives of smooth working in respective schools, the **Rehbar-e-Taleems** so regularized shall not be transferred
