Whereas; the Administrative Department vide letter No. Edu-I/61/2016, dated. 22/03/2016, has forwarded select list of Jr. Assistants issued by the Service Selection Board vide communication No. SSB/Secy/Sel/2016/2051-57, dated. 08/02/2016, District Cadre Kupwara;

Whereas, the post at S.No. 04 in the select list was kept withheld for want of certain clarification in respect of candidate figuring on the said slot as per his merit;

Whereas, in response to this office notification bearing No. DESK/NT/SSB/JA/510/2016/All/784-85, dated. 07/04/2016, the selectees who deposited their documents/testimonials in this Directorate, their appointment vide order No. 776-DESK of 2016, dated. 09/05/2016 has been issued accordingly;

Whereas, the candidate figuring at S.No. 04 in whose favour selection was kept withheld for want of certain clarification, has submitted representation before J&K Service Selection Board, wherein he requested that besides having qualification B.Sc IT through Distance mode has also qualified BBA through regular mode before the cut of date of the advertisement notice, as such his BBA certificate be considered for release of his withheld selection. He has also approached the Hon'ble High Court of J&K Srinagar through SWP No.1228/16 and the Hon'ble Court while disposing of the SWP vide its order dated. 09/06/2016, has directed the Service Selection Board to consider the representation of the petitioner and take a decision thereon in accordance with the rules;

Whereas, in compliance to the directions of the Hon'ble High Court dated 09/06/2016, in SWP No.1228/16, titled Sheikh Ashiq Rasool V/s State & Others the representation of the petitioner has been considered and consequent there upon the withheld selection/recommendations of the petitioner Sheikh Ashiq Rasool S/o Ghulam Rasool Sheikh R/o Lalpora Lolab Kupwara, figuring at S.No. 04 under OM category for the post of Jr. Assistant District cadre Kupwara stands released by Service Selection Board vide order No. 47-SSB of 2017, dated.03/02/2017;

Whereas, the Service Selection Board vide No. SSB/S-15/2016/2120-21/ 2017, dated. 19/09/2017, read with No. SSB/S-15/2016/9686, dated. 22/09/2017, conveyed by the Admn. Deptt. vide letter No. Edu/L/K/04/017, dated. 23/10/2017, has issued merit position of the selectee in whose favour withheld selection/ recommendation was released by J&K Service Selection Board, vide order No. 47-SSB of 2017, dated. 03/02/2017;

Whereas, this office vide Notification No. DESK/NT/SSB/510/B/2016/Kup /1764-65, dated. 02/11/2017, appeared in press through information, directing the selectee/petitioner to deposit his requisite original as well as self attested certificates/testimonials in this Directorate within seven (07) days from the date of publication of the notification in the press;

The candidate is required to report to the Chief Education Office **Kupwara** within (21) days from the date of issuance of this Order, for further posting against the available vacancy in needy institution, on his own risk and responsibility till the verification/ authentication of all relevant documents/Certificate are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009**, dated **24.12.2009**.

The appointee shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer, **Kupwara** who shall to get these certificates verified/authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic /Qualification certificates.
- iii. Technical Certificate.
- iv. Permanent resident certificate
- v. Age and health certificate
- vi. Discharge certificate from the Institution attending/last attended
- vii. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- viii. Category certificates (in case of reserved categories) under SRO.294 of 21/10/2005.
- ix. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- > Satisfactory report about his/her character and antecedents is received from **Inspector General** of **Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his appointment as **Jr. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- > The Chief Education Officer, Kupwara will adjust the candidates against clear vacancy in needy institutions without involving transfers.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/abinitio.
- > He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Kupwara** in any case.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/subjudice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
