Subject:- Selection list of the candidates for the post of Lab. Assistant (Education Department)
District Cadre Budgam, operating wait list thereof.

Whereas, the Administrative Department vide letter No. Edu-I/618/2015, dated.09/02/2016 has forwarded J&K Secretary Service Selection Boards communication No.SSB/Secy/Sel/2015/11977-83 dated.16/11/2015, along-with list of **(11) Eleven** candidates (**OM-07, RBA-03, SC-01**), who have been selected as Lab. Assistants in District Cadre Anantnag, Budgam,;

Whereas, the said selection list was notified, through information department vide this office notification No.DSEK/NT/SSB/LA/506/2016/All/398-99 dated.22/02/2016, directing the selectees to deposit the requisite documents in original as well as self attested certificates/ testimonials in the directorate within ten (10) days from the date of publishing the notification in press;

Whereas, only **(09)** nine candidates (**OM-6, RBA-03**) have deposited their requisite documents, and the provisional appointment order in respect only 08 selectees have been issued, and the provisional appointment order in respect remaining one selectee under RBA, has not been issued, due to reason that his recommendation has been kept withheld by the SSB, for producing his original documents and valid category certificate;

Whereas, **(2)** two (**OM-01, SC-01**) remaining candidates out of **(11)** selectees failed to deposited their documents in this Directorate within the stipulated period and were given one more opportunity for depositing their requisite documents within seven (07) days, vide Notification No. DSEK/NT/SSB/LA/506/2016/All/685-86, dated.25/03/2016, before taking up the matter with the Administrative Department for operation of wait list against these available slots;

Whereas, said two **(02)** selectees again failed to submit their documents in the Directorate within the stipulated period, presuming that these selectees are not interested to join the Department/post.

Whereas, the matter was referred to the Administrative Department vide letter No.DSEK/NT/SSRB/ LA/506/2016/All/873 dated. 26/04/2016, for seeking instructions / orders with regard to operation of wait list, against the slots, which become available due to non depositing of documents by these **02** selectees of District Budgam..

Whereas, the Administrative Department vide letter No. Edu-I/618/2015 dated. 04/06/2015, has conveyed approval for operating of wait list against the slots, which became available due to non-depositing of the documents of the selectees, on standard terms and conditions.

Whereas, One **(01)** candidate under OM category appearing in the wait list of District Budgam, was asked to deposit his requisite original as well as self attested certificates/ testimonials in the directorate within **(10) days** vide this office notification No. DSEK/NT/SSRB/LA/506/2016/All/1219 dated. 22/06/2016.

Whereas, said candidate has failed to deposited his documents/ undertaking in the Directorate, and has given final opportunity to deposit his documents vide this office notification No. DSEK/NT/SSB/LA/506/2016/All/1570 dated.20/09/2016, but he has again failed to deposited his documents in the Directorate within the stipulated time, presuming that he is not interested to join in the department.

Whereas, next in queue in the wait list under OM category namely Mr. Firdous Ahmad Ahangar S/O. Abdul Qayoom Ahangar R/O. Kralpora, was asked to deposit his requisite original as well as self attested certificates/ testimonials in the directorate within **07 days** vide this office notification No. DSEK/NT/SSRB/LA/506/2016/All/1929 dated. 13/10/2016.

Whereas, the said candidate has deposited his documents in the Directorate, for issuance of his provisional appointment order.

Now, therefore, in view of the above, Sanction is hereby accorded to the provisional appointment of Mr. Firdous Ahmad Ahangar S/O. Abdul Qayoom Ahangar R/O. Kralpora Budgam, selected candidate in the wait list, as Lab. Assistant in District cadre Budgam, in the pay band of Rs.5200-20200+ grade of Rs.1900/-. The full particulars/ merit points are indicated against his name.

The candidate is required to report to the Chief Education Office **Budgam** within **10 days** from the date of issuance of this Order, for further posting against the available vacancy in needy institution, on his own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as per SRO-400 of 2009 dated.24.12.2009.

The appointment of the candidate shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Budgam** who shall be required to get these certificates verified / authenticated from the concerned issuing authorities.

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Qualification certificates.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/ last attended
- vi. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- viii. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his/her character and antecedents is received from the concerned Additional Director General of Police (CID) J&K. and genuineness/ verification report for qualification certificates /Technical Certificate /Marks Certificates and category certificates (if any) from the issuing authority.
- He shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned Additional Director General of Police (CID) J&K , the appointee shall have no right to claim his/her appointment as **Lab. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- The Chief Education Officer, **Budgam** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Budgam** in any case, and in case, at any stage it emerges that the certificates/ any relevant document furnished/ produced by the selectee is fake / fictitious, the appointment order shall be cancelled abinitio and criminal proceeding shall be initiated against the candidate.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidates till formal appointment order is issued form this Directorate.

The inter- seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in ay court of competent jurisdiction.
