Whereas, the Administrative Department vide letter No. Edu-I/287/2014-II dated 03.10.2016, forwarded SSB's Order No. 1329-SSB of 2016 dated 27.09.2016 whereunder the recommendation against the blank slot at S.No. 16 under OM Category has been released in favour of Peerzada Shams Din S/o Peerzada Habibullah R/o Kunan Trehgam, Kupwara for further necessary action, under rules;

Whereas, the Administrative Department in their earlier communication No.\*Edu-I/286/2012 dated: 05.09.2012 desired to issue the provisional appointment orders in favour of the candidates for the post of teachers selected by the SSRB after taking the undertaking from the appointee with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department—the selectee were asked to deposit his undertakings on the devised format duly attested by the 1st Class Magistrate—in the Directorate of School Education Kashmir—vide this office notification—No. DSEK/Estt-III/B-Trs./803-05 dated 17.10.2016;

Whereas, in response to the Notification dated 17.10.2016, Mr. Peerzada Shams Din S/q. Peerzada Habibullah R/o Kunan Trehgam, Kupwara whose full particulars are reproduced below whose full particulars are reproduced below submitted his undertaking alongwith original testimonials, for issuance of provisional appointment order, in pursuance to his selection made by the Services Selection Board vide communication referred to above.

Now, therefore, sanction is hereby accorded to the provisional appointment of Mr. Peerzada Shams Din S/o Peerzada Habibullah R/o Kunan Trehgam, Kupwara (whose full particulars are reproduced below) as Teacher in District Cadre Kupwara in the pay scale of Rs.5200-20200 with grade pay of Rs. 2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Kupwara within Ten (10) days from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned agencies.

- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the
  issuing authority and ensure that the merit points reflected in the selection list are recorded according to
  the genuineness marks card /qualification certificate.

The formal appointment order of the selectee shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
