Whereas, the Administrative Department vide No. Edu-I/288/2014 dated 19.08.2014 forwarded the selection list of **396** candidates selected as Teacher District Cadre Anantnag pursuant to the selection made by the SSB vide No. SSB/Sel/Secy/014/6321-27 dated 23.07.2014:

Whereas, among others, selection in respect of one candidate namely Zahida Kousar D/o Mohd Bashir R/o Dandipora Anantnag figuring at S.No. 16 under ST Category was kept withheld by SSB for want of production of Bonafide certificates of PG/Pre-marital ST and PRC certificates;

Whereas, on failing to produce the documents before the SSB, her selection was cancelled vide SSB's Order No. 1314-SSB of 2016 daed 01.09.2016, convyed by the Administrative Department vide letter No. Edu-I/288/2014 dated 06.10.2016;

Whereas, the candidate figuring at S.No. 1 in the Waiting List, namely Firdous Ahmad Khan S/o Ab. Gani Khan R/o Sundbrari, Kokernag District Anantnag approached the Hon'ble High Court through the medium of SWP No.939/2017, titled Firdous Ahmad Khan Vs State and Ors. for seeking directions against the respondents to select and appoint the petitioner on the post of Teacher in the District Cadre Anantnag against the slot of Zahida Kousar D/o Mohd Bashir R/o Dandipora Anantnag figuring at S.No. 16 under ST Category whose recommendation was cancelled by the SSB;

Whereas, the Hon'ble High Court vide order dated 03.06.2017 in MP No. 01/2017 filed in SWP No. 939/2017 has been pleased to direct as under:-

"Application is disposed of by providing that respondents may consider claim of petitioner for the post of Teacher in District Cadre Anantnag, in view of cancellation of selection of private respondent. In strict accordance with rules occupying the field, provided there is no legal impediment and petitioner is otherwise eligible".

Whereas, in compliance to the Hon'ble Court order, the SSB vide Order No. 323-SSB of 2017 dated 28.8.2017 conveyed by Administrative Department vide letter No. Edu/L/K/104/2017dated 06.10.2017 recommended the selection of the petitioner namely **Firdose Ahmad Khan S/o Ab.Gani Khan R/o Sundbrari Kokernag District Anantnag**, earlier figuring at S.No.1 in the waiting list under ST Category by placing him in the selection zone at S.No. 21 under ST Category consequent upon cancellation of withheld selection of Zahida Kousar figuring at S.No. 16 in the selection list of teachers under ST Category in District Cadre Anantnag;

Whereas, in light of earlier instructions of the Administrative Department, a notification vide No. Estt-III/B-Trs/7565-68 dated 22/11/2017 was published through print media whereunder the petitioner was advised to submit his undertaking/other relevant papers within Seven days;



Whereas, in response to the said notification dated 22/11/2017, Firdose Ahmad Khan S/o Ab.Gani Khan R/o Sundbrari Kokernag District Anantnag furnished his undertaking on the devised format duly attested by the 1st Class Magistrate alongwith all requisite documents;

Now, therefore, in compliance to the orders of the Hon'ble High Court and recommendations of the SSB/Administrative Department, sanction is hereby accorded to the provisional appointment of Mr. Firdose Ahmad Khan S/o Ab.Gani Khan R/o Sundbrari Kokernag District Anantnag (whose full particulars are reproduced below) as Teacher in District Cadre Anantnag in the pay scale of Rs.5200-20200 with grade pay of Rs. 2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate required to report to the Chief Education Officer, Anantnag by or before 20th December, 2017 for seeking further posting on his own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned agencies.

The Chief Education Officer, Anantnag shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- · Age and health certificates
- Discharge certificate from the Institution attending/last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the
  issuing authority and ensure that the merit points reflected in the selection list are recorded according to the
  genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn.

The provisional appointment of candidate is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
