Whereas, the Administrative Department vide letter No. Edu-I/227/2016 dated: 30.06.2016 forwarded Secretary Service Selection Board J&K's communication No.: SSB/Sel/Secy/ 2016/12667-73 dated: 11.05.2016 and No.: SSB/Sel/Secy/2016/16014 dated: 07.06.2016 alongwith a list of **Fifty-five (55)** candidates who have been selected as teachers in District Cadre Srinagar, in pursuance to Advertisement Notification No. 03 of 2014 under Item No. 328.

Whereas, vide this office No. DSEK/Estt/III/B-Trs/Notification/592-94 dated 07.09.2016, these selectees, were advised to submit their documents/papers in the Directorate of School Education Kashmir within **Fifteen (15)** days from the date of publication of notification published in local dailies;

Whereas, in response to the said notification dated 07.09.2016, among others, **Sumeena Tariq D/o Tariq Ahmad Rather** figuring at **S.No. 5** under **RBA Category** also deposited her undertaking on the devised format duly attested by the 1st Class Magistrate alongwith self-attested copies of all requisite documents/certificates, However, some discrepancy with regard to 10+2 Marks were found, as such her appointment order was not issued;

Whereas, the marks variation in **10+2** have now been rectified by the SSB vide their letter No. SSB/Sel/Secy/2016/12667-73 dated 19.10.2016 conveyed by Administrative Department vide communication No. Edu-I/227/2016 dated 25.10.2016 as **318 out of 500** instead of **381 out of 500** in respect of the above named selectee;

Now, therefore, in pursuance to the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, sanction is hereby accorded to the provisional appointment of **Sumeena Tariq D/o Tariq Ahmad Rather** figuring at **S.No. 5** under **RBA Category** as Teachers in District Cadre **Srinagar** in the pay scale of Rs.5200-20200 with grade pay Rs.2400 for Under-Graduates, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to Chief Education Officer Srinagar by or before **20th November, 2016** for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies. The appointment shall be subject to the following conditions:-

- i. **The appointees/selectee shall be on probation for a period of two years.**
- ii. **The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.**
- iii. **In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.**

- iv. *The selectee shall give an undertaking by way of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.*
- v. *The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.*

The Chief Education Officer, Srinagar shall allow the candidate to join on the post after verifying the following certificates (in original).

- *Character and antecedents certificates from Additional Director General of Police (CID)*
- *Qualification certificates viz Degree/Marks*
- *Permanent resident certificates*
- *Age and health certificates*
- *Discharge certificate from the Institution attending/ last attended*
- *Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.*
- *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*
- *Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.*

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn, in any case.

The Chief Education Officer Srinagar shall post appointees in Teacher-deficit institutions in the District without involving chain of transfers.


