Whereas, the said selection list was notified, through information department vide this office notification No.DSEK/NT/SSB/LA/506/2016/All/398-99 dated.22/02/2016, directing the selectees to deposit the requisite documents in original as well as self attested certificates/ testimonials in the directorate within ten (10) days from the date of publishing the notification in press.

Whereas, only (14) fourteen candidates have deposited their requisite documents, and their provisional appointment orders were accordingly issued vide order No. 770,-DSEK of 2016, dated 09/05/2016, and No 944 DSEK of 2016 dated 02/06/2016.

Whereas, remaining (03) candidates out of (17) selectees failed to deposited their documents in this Directorate within the stipulated period and were given one more opportunity for depositing their requisite documents within seven (07) days, vide Notification No. DSEK/NT/SSB/JA/510/2016/All/923, dated.26/05/2016, before taking up the matter with the Administrative Department for operation of wait list.

Whereas, these three (03) selectees have again failed to submit their documents in the Directorate within the stipulated period, presumed that these selectees are not interested to join the Department/post.
