Whereas, the Administrative Department vide letter No. Edu-I/225/2016 dated: 05.07.2016 forwarded Secretary Service Selection Board J&K's communication No.: SSB/Sel/Secy/2016/12674-80 dated: 11.05.2016 alongwith a list of **Three (03)** candidates who have been selected as teachers in District Cadre Shopian, in pursuance to Advertisement Notification No. 03 of 2014 under Item No. 324.

Whereas, out of these **Three (03)** candidates, selection in respect of **One (01)** candidate namely Mohd Rafiq S/o Munshi Khan figuring at S.No. 03 under ST Category was kept withheld by the SSB and subsequently, vide SSB's letter No. SSB/Sel/Secy/2016/18596-98 dated: 04.07.2016 conveyed by the Administrative Department vide letter No. Edu-I/225/2016 dated: 21.09.2016, his selection has been released;

Whereas, vide this office No. DSEK/Estt/III/B-Trs/2016-II/623-27 dated 20.09.2016, these selectees, were advised to submit their documents/papers in the Directorate of School Education Kashmir within **Fifteen (15)** days from the date of publication of notification published in local dailies;

Whereas, in response to the said notification dated 20.09.2016, all the Three candidates from District Shopian deposited their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate alongwith self-attested copies of all requisite documents/certificates. However, one candidate from District Cadre Kulgam and Two candidates from District Ganderbal under SC Category failed to deposit their documents in the Directorate within the stipulated time period;

Now, therefore, in pursuance to the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, sanction is hereby accorded to the provisional appointment of **Three (03) candidates under ST Category** (whose full particulars are reflected below) as Teachers in District Cadre **Shopian** in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 for Graduates and above and Rs.2400 for Under-Graduates, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to Chief Education Officer Shopian by or before **30<sup>th</sup> November, 2016** for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies.

- ii. The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009

### **NOTIFICATION**

Whereas, the Administrative Department vide letter No. Edu-I/342/2014 dated 14.10.2014 forwarded the list of 139 candidates selected as Teachers for District Cadre Bandipora pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/8246-52 dated 24.09.2014;

Whereas, 56 posts under OM Category were recommended for appointment as Teacher in District Cadre Bandipora in terms of SSB's advertised Notification 06 of 2013 (Item 390);

Whereas, aggrieved due to non-selection, one, **Mr. Firdous Ahmad Zargar S/o Gh. Mohi-u-din Zargar R/o Bandipora** figuring at **S.No. 13/Wait against** Item No. 390 (Notification 06 of 2013) filed a writ petition in the Hon'ble High Court through SWP No. 67/14 titled Firdous Ahmad Zargar V/s State of J&K and Ors. wherein he made the plea that his B.Ed merit has not been considered by the SSB on the ground that he has not bobbed B.Ed in the OMR application form;

Whereas, the Hon'ble High Court disposed of the instant writ petition with the following order:-  
*"....case of the petitioner is squarely covered by the judgements of this Court references of the cases is also made in the aforeseaid order.  
The facts of this case would reveal that it is covered by judgements of this Court passed in SWP No. 2029/2014, decided on 1<sup>st</sup> June, 2015.  
Moreover by virtue of order dated 1<sup>st</sup> October 2014, Court has directed not to fill up one vacancy of the said post till next date of hearing.  
For the reasons mentioned above, this petition is disposed of and respondents are directed to extend the benefits of the judgements to the petitioner also"*

Whereas, pursuant to the Hon'ble Court directions, the SSB vide order No. 577-SSB of 2016 dated 30.03.2016 conveyed by Administrative Department vide letter No. Edu/Leg/K/194/2014 dated 26.07.2016, recommended the selection of Firdous Ahmad Zargar (Petitioner) S/o Gh. Mohi-u-din Zargar R/o Bandipora for the post of Teacher with revised merit position of 65.8989 by adding Three (03) points of B.Ed Degree to his earlier merit of 62.8989;

Whereas, the Administrative Department vide letter No. vide letter No. Edu/Leg/K/194/2014 dated 26.07.2016 has forwarded SSB's Order No. 577-SSB of 2016 dated 30.03.2016, wherein the selection of Firdous Ahmad Zargar S/o Gh. Mohi-u-din Zargar R/o Bandipora (**Petitioner**) has been recommended as Teacher in District Cadre Bandipora (with merit position 65.8989) issued in compliance to the Hon'ble Court Judgement dated 16.02.2016 passed in SWP No. 67/14 titled Firdous Ahmad Zargar V/s State of J&K and Ors;

Whereas, no slot under OM Category against Item No. 390 (Notification 06 of 2013) was kept reserved by the Directorate and the matter was accordingly taken up with the Administrative Department vide letter No. DSEK/Estt/III/658 dated 24.09.2016 for conveying necessary guidance in view of the non-availability of the slot under the said category/notification;

Whereas, in response to this office communication dated 24.09.2016, the Administrative Department vide letter No. Edu/Leg/K/194/2014 dated 25.10.2016 conveyed that one post of Teacher from amongst the vacancies under direct recruitment quota in District Cadre Bandipora available at present, which may be utilized to settle the case;

Now, therefore, in view of the above and in deference to the Hon'ble Court orders and recommendations of SSB/Administrative Department conveyed vide aforementioned communications, the below named candidate is hereby advised to deposit his undertaking (duly attested) by the Judicial Magistrate (1st Class) on the devised format appended herewith as "**Annexure A**" in the Directorate of School Education Kashmir alongwith all original certificates within **Seven days** from the date of publication of this notification.


