Whereas, the Administrative Department vide letter No. Edu-I/227/2016 dated: 30.06.2016 forwarded Secretary Service Selection Board J&K's communication No.: SSB/Sel/Secy/ 2016/12667-73 dated: 11.05.2016 and No.: SSB/Sel/Secy/2016/16014 dated: 07.06.2016 alongwith a list of **Fifty-five (55)** candidates who have been selected as teachers in District Cadre Srinagar, in pursuance to Advertisement Notification No. 03 of 2014 under Item No. 328.

Whereas, among these **Fifty-five (55)** candidates, selection in respect of **Mehmooda Gulshan D/O Gulam Rasool Rather** figuring at **S.No. 33/RBA** against Notification No. 03 of 2014 under Item No. 328 was kept withheld by the SSB and subsequently, vide SSB's letter No. SSB/Sel/Secy/2016/18593-95 dated: 04.07.2016, conveyed by the Administrative Department vide letter No. Edu-I/227/2016 dated: 06.10.2016, her selection has been released.

Whereas, in response to this office notification No. DSEK/Estt/III/B-Trs/2016-II/945-48 dated 07.11.2016, the above named selectee deposited her documents alongwith undertaking duly attested by the 1st Class Magistrate to submit her documents in the Directorate within Seven (07) days from the date of issuance of notification;

Whereas, vide this office previous notification No. DSEK/Estt/III/B-Trs/Notification/592-94 dated 07.09.2016, Fifty (50) selectees, were advised to submit their documents/papers in the Directorate of School Education Kashmir within **Fifteen (15)** days from the date of publication of notification published in local dailies;

Whereas, in response to the said notification dated 07.09.2016, among others, **Lavan Kumar** figuring at **S.No. 5 under SC Category** approached this office by late of one month and requested for acceptance of his documents for issuance of provisional appointment in his favour in pursuance to his selection made by the SSB/Administrative Department vide aforementioned communications, as he didn't got information with regard to submission of the documents in the Directorate of School Education Kashmir, being a resident of far flung area of Jammu Division.

Whereas, while taking a lenient view, the request of the candidate was considered and late submission of requisite documents by the selectee was condoned;

Now, therefore, in pursuance to the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, sanction is hereby accorded to the provisional appointment of **Two (02)** candidates (whose full particulars are detailed below) as Teachers in District Cadre **Srinagar** in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 for Graduates and above and Rs.2400 for Under-Graduates, admissible under SRO-93 dated 15.04.2009.. The candidates are required to report to Chief Education Officer Srinagar within **Ten (10) days** from the issuance of this order, for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies.

The appointment shall be subject to the following conditions:-

- The appointees/selectee shall be on probation for a period of two years.*
- The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.*
- In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.*
- The selectee shall give an undertaking by way of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.*
- The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.*

The Chief Education Officer, Srinagar shall allow the candidate to join provisionally on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such order shall be drawn, in any case.

The Chief Education Officer Srinagar shall post appointees in Teacher-deficit institutions in the District without involving chain of transfers.

Whereas, the Administrative Department vide letter No. Edu-I/287/2014 dated 13.08.2014 forwarded the list of **563** candidates selected as Teachers for District cadre **Kupwara**, pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/6328-34, dated 23.07.2014;

Whereas, among these 563 candidates, many slots were kept blank by the SSB for want of certain clarification with regard to equivalence of their degrees with that of the degrees awarded by J&K BOSE/University of Kashmir;

Whereas, the Administrative Department vide letter No. Edu-I/287/2014-II dated 13.10.2016, forwarded SSB's Order No. 1313-SSB of 2016 dated 31.08.2016 whereunder the recommendation against these blank slots at **S.No. 142, 168, 270, 09/Wait, 36/Wait** under **OM Category** and **51 and 106** under **RBA Category** have been released in favour of the **Seven (07)** candidates for further necessary action, under rules;

Whereas, the above order of SSB dated 31.08.2016 reveals that with regard to equivalence of 10+2, Graduation & B.Ed., the clarification was sought by the SSB vide their communication SSB/Sel/Secy/14/7910 dated 03.09.2014, No. SSB/Sel/Secy/2014/5140-41 dated 17.06.2014 and No. SSB/Sel/Secy/14/3634-035 dated 30.12.2014;

Whereas in response, the School Education Department has intimated vide letter No. Edu/NC/SE/411/2013 Part-II dated 11.04.2016 as under:-

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 desired to issue the provisional appointment orders in favour of the candidates for the post of teachers selected by the SSRB after taking the undertaking from the appointee with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department the selectee were asked to deposit his undertakings on the devised format duly attested by the 1st Class Magistrate in the Directorate of School Education Kashmir vide this office notification No. DSEK/Estt-III/B-Trs./Sel/2014/926-28 dated 03.11.2016;

Whereas, in response to the Notification dated 17.10.2016, all the Seven (07) selectees submitted their undertakings alongwith original testimonials, for issuance of provisional appointment order, in pursuance to their selection made by the Services Selection Board vide communication referred to above.

Whereas, after examination of the documents, some discrepancy with regard to Marks in respect of Two (02) candidates has been observed, which need clarification from the competent authority, leaving Five (05) candidates against whom no observation has been recorded;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Five (05)** candidates (whose full particulars are reproduced below) as Teacher in District Cadre Kupwara (against item No. 387 of Notification 07 of 2010), in the pay scale of Rs.5200-20200 with grade pay of Rs. 2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the Chief Education Officer, Kupwara within Ten (10) days from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned agencies.
