Whereas, the Administrative Department vide letter No. Edu-I/56/2017 dated: 05.06.2017 and No. Edu-I/56/2017 dated 17.04.2017 forwarded the selection list of **Twenty-two (22) and Sixty (60)** candidates selected as Teachers in District Cadre Shopian and Anantnag respectively, under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/696-702 dated 17.01.2017 against Notification No. 01 of 2012 dated;

Whereas, among these selectees, recommendation in respect of **02** candidates namely **SONIA RAINA D/o SOOM NATH RAINA** figuring at **S.No. 9** in District Cadre Shopian and **ANIL KUMAR RESHI S/o MADSDUDAN RESHI** figuring at **S.No. 38** in District Cadre Anantnag was kept withheld by the SSB for certain clarification, and has now been released vide SSB's letter No. SSB/Secy/Sel/Tr/Mig/Ang/V/2017/10123-25 dated 05.10.2017 and No. SSB/Secy/Sel/Tr/Mig/Spn/26/2017/9522-24 dated 20.09.2017 conveyed by Administrative Department's communication No. Edu-I/56/2017 dated: 20.12.2017;

Whereas, in response to this office notification No. DSEK/Est/III/B-Trs/PMP/017/192-94 dated 17/01/2018 **Two (out of 03)** candidates furnished a copy of their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009, in the Directorate of School Education Kashmir, for issuance of provisional appointment orders in their favour;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two(02) candidates** (whose full particulars are reproduced below) as **Teachers** in **District Cadre Shopian/Anantnag** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the Chief Education Officer, **Shopian/Anantnag** within **Ten (10)** days from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.

- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointees shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointees shall be fixed at the places on the posts of their first appointment in that particular grade/service and the provisional appointee shall be on probation initially for a period of Two years.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.


