

Whereas, the Administrative Department vide letter No. Edu-I/32/2016, dated 22/03/2016 has forwarded J&K Secretary Service Board's Communication No.SSB/Secy/Sel/2016/938-44 dated. 19/01/2016 alongwith list of **(08)** eight (OM=07, SC=01) candidates, selected as Junior Assistants in District Cadre Baramulla, besides two selection slots at S.No. 06 & 08 under OM category were kept blank (withheld) for want of certain certificates from the eligible candidates;

Whereas, the said selection list was notified, through information department vide this office notification No.DSEK/NT/SSB/JA/511/2016/All/782-83 dated.07/04/2016, directed the selectees to deposit the requisite documents in original as well as self attested certificates/ testimonials in the directorate within ten **(10)** days from the date of publishing the notification in press;

Whereas, only **05 (five)** candidates **(OM =04 SC=01)** have deposited their requisite documents, and their provisional appointment order issued accordingly vide order No. 765-DSEK of 2016 dated. 09/05/2016;

Whereas, three **(OM=03)** remaining candidates out of **07 (seven)** selectees failed to deposit their documents in this Directorate within the stipulated period and were given one more opportunity for depositing their requisite documents within seven (07) days, vide Notification No. DSEK/NT/SSB/JA/511/2016/All/923, dated: 06/05/2016;

Whereas, the said **three** selectees again failed to submit their documents in the Directorate within the stipulated period, presumed that these selectees were not interested to join the Department/post;

Whereas, the matter was referred to the Administrative Department vide letter No.DSEK/NT/SSRB/ JA/511/All/155 dated. 10/06/2016, for seeking instructions / orders with regard to operation of wait list, against the slots, which become available due to non depositing of documents by these **three** selectees of District Baramulla.

Whereas, the SSRB Srinagar, vide communication No. SSB/Sel/Secy/2016/16820-22 dated 16/06/2016, received through Administrative Department vide letter NO. Edu-I/32/2016, dated. 03/10/2016, has released the withhold recommendation in respect of **S.No. 06 & 08** and issued select list of two Jr. Assistant namely Ishfaq Mohi Ud Din S/O Gh. Mohi Ud Din Bhat & Azhar Basheer Bhat S/O Basheer Ahmad Bhat, in District cadre Baramulla;

Whereas, these two selectees have been informed to deposit their original as well as self attested certificates/testimonials in this Directorate within **(10)** days from the date of publication of the notice in press vide this office Notification No. DSEK/NT/SSRB/511/2016/JA/2052-56 dated. 22-10-2016 appeared in daily Kashmir Uzma on 22-10-2016 through information department;

Whereas, in response to the notification these two selectees have deposited their requisite documents for issuance of their appointment order;

The appointee shall be governed under New pension Scheme as per SRO-400 of 2009 dated.24.12.2009.

The appointment of the candidates shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Baramulla** who shall be required to get these certificates verified / authenticated from the concerned issuing authorities.

- Character and antecedents certificate from Additional Director General of Police (CID).
- Qualification certificates.
- Permanent resident certificate
- Age and health certificate
- Discharge certificate from the Institution attending/ last attended
- Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme have been taken by the appointee.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about their character and antecedents are received from the concerned Additional Director General of Police (CID) J&K. and genuineness/ verification report for qualification certificates /Technical Certificate /Marks Certificates and category certificates (if any) from the issuing authority.
- They shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about their character and antecedents is received from the concerned Additional Director General of Police (CID) J&K, the appointee shall have no right to claim **their** appointment as Jr. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
- The Chief Education Officer, **Baramulla** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/ abinitio.
- They shall give an undertaking duly attested by the Judicial Magistrate 1st Class that they will not apply for transfer from District Cadre in any case.


