They shall be allowed to join only on production/verification of the following bona-fide certificates/documents in original after satisfying the eligibility criteria as per the recruitment rules and all other formalities/conditions required to be fulfilled for direct recruitment.

- i. **Character and antecedents certificate from Addl. Director General of Police (CID).**
- ii. **Academic/ Technical Qualification certificates. .**
- iii. **Age and Matriculation/date of birth certificate.**
- iv. **Health certificate issued by the Chief Medical Officer.**
- v. **Permanent Resident Certificates issue by the competent Authority.**
- vi. **Sports category certificates.**
- vii. **No Loan certificate under self-employment scheme from Industries/Employment Department.**

- viii. Undertaken duly attested by the Judicial Magistrate 1st Class to the effect that if it emerges, that the certificates/documents furnished by the appointee/s are fake fictitious his order shall be cancelled ab-initio and criminal proceedings shall be initiated against him.
- ix. The inter-seniority of the appointee shall be in the order in which their names appear in the appointment order.
- x. The appointment/adjustment is subject to the final outcome of the court cases. If any pending in any Hon'ble Court of law, or any order which may not be immediately within the knowledge to this office.

The appointment order shall be subject to ab-initio cancellation in case, at any stage, it emerges that the certificates/documents furnished by the appointees are fake/fictitious.

The Chief Accounts Officer DSEK (DDO)/Chief Education Officer Srinagar, shall take up the verification of Character and antecedents of appointees from ADGP/IGP, CID and academic certificates and other testimonials from the concerned issuing authorities.

After receiving the necessary verification report from the issuing authority duly counter-signed by CAO DSEK/CEO Srinagar, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidates till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which their name appear in the appointment order.

The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in ay court of competent jurisdiction or any order which may not be presently within the knowledge of this Directorate.
