Whereas, on the recommendations of the JKSSB/Administrative Department, as many as 873 candidates were provisionally appointed as Teachers in District Cadre Kupwara/Ganderbal by this Directorate during the year 2014-15 with the explicit condition that no salary shall be drawn till issuance of formal/confirmation to the provisional appointment orders;

Whereas formal appointment orders were issued in respect of all such candidates in whose favour satisfactory verifications reports from the issuing authorities were received through concerned Chief Education Officers by this Directorate from time to time;

Whereas, after lapse of a long time, the Chief Education Officer Kupwara/Ganderbal projected number of such case files and forwarded to this Directorate for issuance of confirmation to the provisional appointment orders;

Whereas upon examination of these case files, it was observed that good number of DDO's in District Kupwara/Ganderbal have drawn and disbursed salaries of Teachers in violation of standing orders/instructions;

Whereas, the issue was again examined by this office on the basis of fresh recommendations and the documents provided by the concerned Chief Education Officers and it was decided to issue confirmation to the provisional appointment of such appointees and the DDO's who have drawn the salaries unauthorizably need to be pinpointed for disciplinary action;

Whereas, different communications were made by this Directorate with the concerned Chief Education Officers during the period in question and it was intimated that these Teachers are satisfactorily working in the Department and their all testimonials/ certificates/character antecedents have been found correct/genuine and recommended the confirmation to their provisional appointment orders;

Now, therefore, sanction is hereby accorded to the:-

- i. Confirmation to the provisional appointment orders in respect of **Fifty-four candidates (31/Kupwara + 23/Ganderbal)** who stand provisionally appointed as Teachers in District Cadre Kupwara/Ganderbal vide various orders as shown in the **Annexure A & B to this order** against each.
- ii. Chief Education Officer Kupwara/Ganderbal are nominated as Enquiry Officers to enquire into the matter and shall pinpoint the names of each DDO of the respective Districts alongwith concerned Dealing Assistants who have drawn the salaries of these Teachers in violation of the standing orders/instructions to initiate disciplinary action against these erring Officers/Officials. **The Enquiry Officers shall furnish their reports within 15 days to this Directorate.**

This order is issued without prejudice to any writ petition/suit, if any, pending/subjudice before the Hon'ble Court or any other Court of law.
