Whereas, the Administrative Department vide letter No. Edu-I/145/2014 Dated 07/07/2014 forwarded the list of 73 candidates selected as Teachers for District cadre Ganderbal. pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/014/4443-49 dated 03.06.2014. and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;


Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

- **The salary in favour of the selected candidates is only drawn:-**
- *After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;*
- *After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;*
- *The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)*
- *If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.*
- *The appointee shall furnish an undertaking (as per Annexure) duly attested by the Judicial Magistrate.*

Whereas, in light of above instructions of the Administrative Department all the selectees in whose favour the selection was released by the SSB were advised to furnish their undertakings on the devised format duly attested by the 1st Class Magistrate in the Directorate of School Education Kashmir for favour of further necessary action in response to DSEK's notification No. DSEK/Estt-III/B-Trs./34/2014/Sel/Gbl/3571-72 dated:14/08/2014etc;

Whereas, in response to this office notification dated: 14/08/2014, **43 (Out of 47)** furnished their undertakings on the devised format duly attested by the 1st Class Magistrate in this Directorate and accordingly this office issued provisional appointment orders in favour of **43** candidates vide Order No. 1270-DSEK of 2014 dated 30-09-2014 with the rider that they will report to Chief Education Officer Ganderbal for further posting. Besides vide order No. 1484-DSEK of 2014 dated 31-12-2014, 1480-DSEK of 2014 dated 31-12-2014, No.362-DSEK of 2015 dated 20.02.2015 and No. 833-DSEK of 2015 dated 27-03-2015. the provisional appointment orders in favour of **06, 14, 02 & 02** selectees respectively has been issued as their selection was released later in phased manner vide various communications;

Whereas, in continuation to letter No. CEO/Gbl/Estt-I/ 6499 dated 21.11.2014, Chief Education Officer Ganderbal vide No. CEO/Gbl/Estt-I/02/152 dated 04.04.2015 intimated that one more candidate namely **Hilal Ahmad Wani S/O Nazir Ahmad Wani R/O Shah Saadiq Qalander Mohalla, Lar Ganderbal** figuring at S.No. 11 under OM Category Item No. 284, Notification



No. 03 of 2012 (detailed below) has failed to join at his respective places of postings (i.e. BHS Cherwan) after issuance of provisional appointment orders in his favour;
