6. No Objection certificate from DIC/Employment Exchange.
7. That these appointees have not been selected by any Recruiting Agency/or appointed in any other Government Department.
8. That the allowance other than what was admissible/due has not been drawn.
9. That these employees are working against clear vacancies/posts and have not been conveyed/recommended earlier by the Empowered Committee.

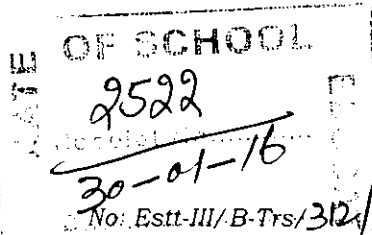

District Kupwara=04 (four) Teachers and District Kulgam=02 (Two) Teacher is forwarded to the Chief Education Officer, Kupwara/Kulgam for information and further necessary action after observing / verifying/fulfilling all the terms and conditions as laid down in the aforesaid Government Order and will also strictly adhered the following conditions too:-
