Whereas, Application Forms on prescribed format were invited from in-service desirous un-trained graduate/post-graduate Teachers of the School Education Department (Kashmir Division) having acquired graduation as on **01/01/2017** and whose date of appointment / promotion / regularization as Teacher falls upto **01/01/2007** (in case of General category aspirants) and upto **01/01/2014** (in case of Reserved category aspirants) for undergoing B.Ed. (Regular) during the **Session 2017-18** vide this Office Notification issued under No. Estt-III/NG/A/B.Ed./5226-36 Dated 24/12/2016;

Whereas, Joint Director (Incharge Migrant Cell) Directorate of School Education, Jammu and Chief Education Officers were notified to furnish the consolidated list of such applications alongwith forms and requisite documents in order of seniority within **seven days** from the last date of receipt of application forms;

Whereas, all the Chief Education Officers (except CEO Leh/Kargil) & Joint Director Incharge Migrant Cell, Directorate of School Education, Jammu have furnished the requisite lists of desirous in-service Teachers for undergoing the **two year** B.Ed.(Regular Course) through Institute of Advanced Studies and Education (Formerly Government College of Education, Srinagar);

Whereas, these lists have been consolidated by this Office in accordance of eligibility / seniority and accordingly a tentative consolidated list of **697** in-service Teachers has been prepared and made available on the official website of this Directorate viz **www.dsek.nic.in**;




Now, therefore, the tentative list as framed on the basis of data provided by the Chief Education Officers (except CEO Leh/Kargil) and Joint Director Incharge Migrant Cell, Directorate of School Education, Jammu is hereby notified for inviting of objections/verification of particulars. Variation/discrepancy if any found on consequent verification shall be brought to the notice of this Directorate with documentary evidence through Chief Education officer concerned within a period of **seven days** from the date of publication of the Notification. No such objection/claim preferred without routing the same through the concerned Chief Education Officer shall be entertained. While submitting the objections if any, the Chief Education Officers will furnish a clear cut certificate to the effect that the particulars of a Teacher reflected in the tentative list are correct as per their service records and none of the Teacher have been deputed for the said training prior to this list.

After expiry of stipulated period of **seven days**, no objection/claim whatsoever shall be considered.
