- a) That the appointee/s shall be initially on probation for a period of five years and after completion of five (5) years of their service/s, they shall be declared as permanent subject to passing of such tests or successfully undergoing such training as provided under Rule-8 of SRO-202 of 2015 dated:- 30-06-2015.
- b) The appointees shall have to necessarily work for a period of five (5) years on the post against which he/she has been appointed and such appointees shall not be eligible for transfer for whatsoever reason during the temporary service of five years.
- c) That any person appointed against any available vacancy on the basis of being a resident of backward area or an area adjoining Line of Actual control shall serve in such area for a period of not less than seven (7) years.
