
Pursuant to the selection made by the University of Kashmir, sanction is hereby accorded to the deputation of **27 (Twenty Seven)** in-service graduate Teachers of the department for post-graduate Course at the University of Kashmir (Srinagar) during the session 2015-16 in terms of Government Order No. 1003-Edu of 1987 Dated:- 01/06/1987, 503-Edu of 1999 Dated:- 13/04/1999 and 12-Edu of 2005 dated:- 20/01/2005, whose particulars are indicated in the list forming **Annexure-A** to this order.

The depute who leaves the course half way on any ground shall be allowed to resume his/her normal duties at the respective places of posting after fulfilling all the conditions as envisaged in the above referred Govt. orders which are highlighted below:-

- ❖ **One year's increment shall be stopped with the effect of post-ponement of future increments.**
- ❖ **The intervening period which has been spent under training by such a teacher shall be treated as on leave whatever kind due and salary drawn by him/her adjusted accordingly.**

The drawing and Disbursing Officers/Chief Education officers shall implement the deputation order in respect of the officials only after observing the following conditions:-

- i. **The selected teacher who may be found as not eligible or who on consequent verification by the CEO/DDO is not having the eligibility shall not be relieved.**
- ii. **An undertaking may be obtained from each depute on a non-judicial stamped paper pledging besides the above condition that in case he/she fails in the P.G course he/she shall forfeit the chance of re-deputation to the Course and that he/she shall abide by the conditions to be prescribed by the Government/University.**


