Pending clearance by the DDPC and vigilance GAD (Vig), Sanction is accorded to the placement of following **08 (Eight)** Laboratory Assistants as **Incharge Teachers** in their own pay and grade for a period of six months on stop gap arrangement basis in the District cadre Ganderbal.

The placement of Laboratory Assistant as I/C Teacher shall be subject to fulfilment of the following explicit conditions:

- i) If any Laboratory Assistant as named above in the placement order, on subsequent verification, is found not to be eligible for such placement, this order will not confer any right on them and his/her placement on the higher post (made hereby) shall liable to be rescinded in that case. It will be personal responsibility of the Chief Education officer/Drawing and Disbursing Officer to verify particulars of the Laboratory Assistant with reference to his/her original service records/ appointment/ promotion orders and ensure that the date of Ist appointment/promotion as Laboratory Assistant as well as other particulars recorded against them in the placement order are correct. Variation if any found should be brought to the notice of this Directorate for further orders. And in that case no such Laboratory Assistant be relieved for their placement on the higher post until further clarification /instructions in the case is sought from this Directorate.
- ii) The benefit of placement shall not be allowed in case an official be either under suspension or whose suspension period would be still undecided or in the case of an official against whom departmental proceedings/VOK may be pending or whose work and conduct may not be satisfactory.
- iii) The placement shall be without pre-judice to the final out-come of the court case, if any sub-judice /impugned or pending before the Hon'ble High Court or any other court of law and other orders, if any passed by the competent authority, which are not immediately within the knowledge of this Directorate.
- iv) That the Laboratory Assistant must necessarily be holding genuine appointment on substantive basis and un-interrupted service, and shall not falls in the category of fake, fraud, adhoc/contractual appointment/migrant substitute, and are not subject to any criminal proceedings departmental/VOK.
- v) The Chief Education officer must ensure that there is nothing adverse against the official from VOK/Crime/Police.
- vi) The placement order in respect of aspirants shall be allowed only after production/obtaining verification of original qualification and category certificate from the issuing/competent authority.
- vii) The placement of the officials shall be without pre-judice to the superior claim if any of others.....Cont...

- viii) that the work and conduct of the official has remained satisfactory during working as Laboratory Assistant.
- ix) Superior claim vis-à-vis inter-se-placement of the officials for re-determination of Seniority in the cadre of Laboratory Assistant, if any shall be submitted to this Directorate within a period of one month through proper channel.
- x) The Migrant Laboratory Assistant placed as I/C Teacher shall report to this Directorate alongwith Service Book and all other allied documents/papers within ten days from the date of issuance of this order, after getting themselves properly relieved by the concerned DDOs duly counter signed by the Joint Director Migrant Cell Jammu, for seeking their formal posting orders, failing which it shall be construed that they are not willing to avail the benefit of this placement and their placement as such shall be deemed to have been cancelled without serving any further notice
- xi) The APRs for preceding three years reviewed and accepted in respect of the elevated officials alongwith full posting details institution wise since initial appointment till date with parentage and residential address be furnished for taking up the issue for vigilance clearance with the concerned department.
- xii) The Chief Education Officer, Ganderbal will also ensure that the qualification/category certificates /appointment order of each elevated official has been verified and found genuine/correct one and also ensure that none of the elevated official is possessing the "Adeeb qualification" (only English) before formal posting orders are issued and will furnish specific report in this regard to this Directorate.
