Subject:- Grant of Promotion IN-SITU of Higher Standard pay scale.

**ORDER NO:- 219 DSEK OF 2018
DATED:- 22/ 02 / 2018**

Sanction is hereby accorded to the grant of promotion In-Situ to the Higher standard pay scale in terms of J&K Civil Services (Higher Standard Pay Scheme) Rules 1996 issued by J&K Government vide SRO-14 dated. 15.01.1996 in favour of **27** teaching personnel's (**Masters/Generals Line teachers**) in the pay band with grade pay from the date as indicated against each in the Annexure to this order, on notional basis from the date they are eligible and with monetary benefits w.e.f. 01.03.2015, in terms of rule 2.43 of financial code Vol-I.

The particulars of these official in whose favour of time bound promotion is being granted / released are shown in the Annexures as detailed below:-

District Baramulla (Annexure-A)= 02	District Budgam (Annexure-B)= 01	District Kulgam (Annexure-C)= 09	District Kupwara (Annexure-D)= 04

The promotion IN-SITU to the Higher Standard Pay Scale in favour of teaching officials, is granted / released subject to the fulfilment of the following conditions:-

1. The Chief Education Officer/ Drawing & Disbursing Officer concerned will verify the particulars of each official with reference to his / her original service records before allowing (IN-SITU) promotion benefit and he/she shall be personally responsible for correctness of the particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and such cases shall be referred to the Directorate for further orders / clarification.

2. That the incumbents has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in Rule 4(k) of SRO-14 dated.15.01.1996.

3. That the incumbents was not under suspension or contemplated in any charge or charge- sheet under Classification and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory.

4. That the present promotion In Situ shall not change / affect the existing designation / seniority/ duties of the employees.

5. That the benefit of the promotion In-Situ shall not be applicable, if the official who has earlier foregone regular/functional promotion or will forego his functional promotion in future.

6. That before implement the order, the concerned CEO shall ensure that the employees are holding substantive appointment and genuineness, before endorsing this order to sub-Offices for implementation.

7. That time bound promotion has been accorded by the DDO/CEO at his own in favour of any official and none of the officials has received this benefit so far.

8. Case. If it has been found that the time bound promotion has been sanctioned in favour of RRT teacher by virtue of this order, the same should not be given effect as the time bound sanction of RRTs will be considered separately.

9. That upon grant of HSPs, their pay fixation and pay/pension arrears admissible from the date the HSPs has / been granted shall be regulated strictly in accordance to the provisions laid down in SRO-93 dated. 15.04.2009 and Govt. Order No.08-F and Govt Order No.08-F dated.18.01.2011 read with SRO-42 dated.02/02/2011 and Govt Order No 238-F dated.30.09.2011.

10. That the CEO concerned shall allow the benefit of In-Situ promotion in respect of erstwhile FAT /Migrant teachers only after verification their service bio-data with original documents viz; service book, appointment order , qualification certificate and regularization order of the competent authority.




