The candidate(s) are required to report the Chief Education Officer, Bandipora, within 21 days from the date of issuance of this order. In case the appointees do not join within the stipulated period their appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on production/checking/verification of the following certificates in original.

1. Academic/ Technical Qualification certificates.
2. Matriculation/Date of Birth certificates.
3. Health Certificate issued by Chief Medical Officer.
4. Permanent Resident Certificate issued by the Competent Authority
5. Certificate from the concerned authorities to the effect that no loan under the self employment scheme has been taken by the appointee concerned.
6. Category certificate (if any)
7. Disability certificate (if any)

The appointment of the above candidates shall further be subject to the following conditions:-

1. Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his/her academic/technical/category certificates wherever applicable and also character and antecedents is received from concerned issuing agencies/Inspector General of Police (CID) to whom a reference shall be made by concerned within whose jurisdiction he/she is posted, he/she shall have no right to claim his/her appointment as "Junior Assistant" as such shall be deemed to have been cancelled ab-initio.
2. If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
3. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned authorities.
4. The appointment order shall be governed under new pension scheme as per SRO-400 dated 24/12/2009
5. The appointment of the candidate as "Junior Assistant" shall be subject to outcome of the writ petition(s) if pending any court of law, which may not be immediately within the knowledge of this Directorate.
6. The inter-se seniority of the appointees shall be in the order of merit of the J&K Service Selection Board;
7. The appointee shall be on probation for a period of two years in terms of S.O 192 dated 17/06/2020 however, the appointee under these rules shall have to necessarily work for a period of five years on the post against which he/she has been initially appointed and such appointee shall not be eligible for transfer for whatsoever reason during the period of five (05) years.
8. During the period of probation, the appointee under SO 192 dated 17/06/2020 shall be entitled to the minimum of pay level applicable to the post against which he/she is appointed.

Whereas, the matter regarding the non-joining of candidates and operation of waitlist thereof, was taken-up with the Administrative Department vide this office letter No. DSEK/NT/SSB/574/2019/Bpr/1332 dated 27/08/2019;

Whereas, the Administrative Department vide letter No. Edu-I/842/2018, dated 15/10/2019, conveyed approval for operation of waitlist against (05) resultant vacancies (OM=04, SC=01) of Junior Assistants, District cadre Bandipora in favour of the candidates who are next in queue in the waiting list strictly in order of merit;
