As approved by the Departmental Committee constituted for the purpose, sanction is hereby accorded to the appointment of Mtr. Romana Batool (BA), Date of Birth 12/05/1997 D/o Ghulam Nabi Thoker / Late Rafiqa Bano (deceased Teacher, Primary School Sanzwatroo), Zone Pulwama who died in harness on 29/05/2017) R/o Gudoora Tehsil and District Pulwama as (Laboratory Assistant) on vacant post in Higher Secondary School Samboora on compassionate grounds under SRO-43 of 1994, against the identified vacant post in District cadre Pulwama, in the pay scale of Rs.5200-20200 with grade pay of Rs.1900/- The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production /verification of the following certificates in original:

L. Age and health certificate.

2. Academic qualification certificates (from recognized Board/University).

Permanent Residence Certificate.

No Loan certificate from DIC/Employment and Counseling Centre;

Character/ Antecedents verification certificate from IGP, CID.

Affidavit to the effect that in case of adverse report from CID she will not claim for the post/salary.

- Fresh affidavit from appointee duly sworn before Judicial Magistrate to the effect that in the event of her failure to look after the family of the deceased Teacher, he shall have no claim to continue on the post.
- Fresh Affidavits of all family members with regard to surrender claim in favour of the appointee (duly sworn before 1st Class Magistrate);
- 9. If on the verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.
- 10. The appointee shall be governed under new pension scheme as per SRO 400 of 2009 Dated 24/12/2009.

In case the appointee fails to join or to produce the requisite certificates within **21 days** from the date of issuance of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence/anticipation of verification of her character/antecedents report from the CID/ verification report of PRC/Date of Birth and qualification certificate. In case of adverse report from the CID or adverse verification reports of PRC/DOB/Qualification certificates from the concerned issuing authorities, this order should be deemed to have been cancelled ab-initio and the appointee will have no claim for salary for the period size worked as such, an undertaking to this effect be also obtained from his for record and reference.
