# Annexure "A" to Government Order No. $\frac{639}{26}$ -Edu of 2018, dated $\frac{2}{2}$ . 04 . 2018

#### Procedure/Terms and conditions for temporary engagement

- 1. The candidate is a permanent resident of J&K state.
- 2. The candidate is qualified for the post as per prescribed rule and preference will be given to the candidates having higher qualification and those having passed B.Ed., M.Ed.
- 3. The candidate is within the age limit required under rules as on first January of the year in which the academic arrangement is made.
- 4. The candidate be allowed to join provided that the post is vacant.
- 5. The candidate shall execute an agreement with the concerned DDO that he/she shall have no claim or right for appointment on permanent basis and there will be no commitment of the State Government in this behalf. The academic arrangement of the candidate shall automatically cease or stand cancelled on completion of the academic session or as and when the post is filled up on regular basis by the Service Selection Board, whichever is earlier.
- 6. The concerned Chief Education Officer will obtain an undertaking from the candidate to the above fact that they shall not insist for regularization extension/continuation of their service on any ground whatsoever and will ensure that during engagement the candidate has to abide by Government service conduct rules and as per terms and conditions of engagement provisions laid down by the department from time to time.
- 7. After receipt of applications from the eligible candidates, the concerned CEO shall prepare a merit list on the basis of marks obtained by the candidate in the academic qualification, however, weightage may also be given to higher qualification acquired by the candidate.
- 8. Thereafter, the final selection list of the candidates equal to the number of vacancies shall be prepared and accordingly adjust the candidates on these vacancies.
- 9. The merit list so prepared shall be valid for one academic session only.
- 10. Waiting list of candidates may also be maintained and in case an engaged candidate leaves the department during the academic session, then next candidate in the merit list will be considered for academic arrangement against the vacancy accrued. The waiting list shall be valid for once academic session only.
- 11. The engagement order shall incorporate the terms and conditions as reflected above.

12. The engagement order as Teacher on academic arrangement basis shall be issued by the concerned Chief Education Officer, under his signatures.
