Whereas, the Administrative Department vide letter NO:Edu-I/305/2014 dated 20/10/2014 forwarded the list of (16) Sixteen candidates under different categories i.e. OM - 08, RBA = 03, SC = 02 + 02 = (04) as per annexure 'A' & 'B' and ST = 01 for the post of Laboratory Assistants in Education Department District cadre Baramulla, pursuant to the selection made by the J&K Services Selection Board, Jammu vide NO:SSB/Sel/Secy/014/6690-96 dated: 4/08/2014 and advised to issue appointment orders only after authentication/ verification of all original certificates/character antecedents (resident of concerned District/Division for a period not less than 15 years) etc/required under rules.

Whereas, the Administrative Department has also conveyed guidelines to issue the provisional appointment order in favour of selectee after obtaining the under taking on the devised format with the following explicit conditions:

The salary in favour of the selected candidates is only drawn:-

After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;

After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;

The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (copy enclosed) to the effect.

If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled ab-initio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of the above instructions of the Administrative Department the selectee were asked to deposit their undertakings on the devised format duly attested by the Ist. Class Magistrate in the Directorate of School Education Kashmir vide this office Notification NO; DSEK/ NT/ SSB/ LA/ 492/ 2014/Bla/628-29 dated: 21/01/2015.

Whereas, in response to the said notification dated: 21/1/2015 only one candidate namely Mr. Bilal Ahmad Bhat S/o Ab. Rashid Bhat under RBA category figuring at S. No. 03 (annexure -B) submitted his undertaking.

Whereas, the case was taken up with Administrative Deptt. Vide this office letter No. DSEK/ NT/ SSB/ LA/ 492/ 2014/Bla/1813 dated: 15-05-2015 for conveying approval to operate the wait list in favour of next meritorious candidate.

Whereas, Administrative Deptt. Vide letter No. Edu - 01/305/2014 Dt. 28-07-2015 conveyed approval to operate wait list.

Whereas, the below named candidates existing in the wait list were asked to deposit their undertakings duly attested by the judicial magistrate 1st Class and other testimonials on devised format within 10 (ten) days before DSEK vide this office notification published in the News Paper through Information Deptt. Vide this office letter No. DSEK/ NT/ SSB/ LA/ 492/ 2014/Bla/2462-64 dated: 19-08-2015.

Whereas, in response to this office notification Dt. 19-08-2015. Mr. Imtiyaz Ahmad Ganaie S/o Ghulam Mohi ud Din Ganaie R/o Hardichloo Tangmarg existing at S. The Chief Education Officer Baramulla shall allow the candidate to join on the post after verifying the following certificates (in original):

- Character and antecedents certificates from Additional Director General of Police (CID).
- Qualification certificates viz Degree/Marks/Permanent resident certificates
- Age and health certificates
- Discharge certificate from the institution attending/last attended.
- Category certificates under SRO-294 of 21/10/2005.
- Certificate from the concerned authority to the effect that no loan under self employment scheme has been taken by the concerned candidates.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and to ensure that the merit points reflected in the selection list are recorded according to the genuine marks card/qualification certificate.
- The confirmation of the provisional appointment order of the candidates shall be issued by the DSEK only after receiving verification reports of date of birth certificate/qualification/Marks certificate/ category certificate and other certificates from the issuing authority through concerned Chief Education Officer and no salary in any case till issuance of such orders shall be drawn.
- The inter-se-seniority of the appointee shall be in the order in which their name appear in the select list furnished by the J&K SSRB.
- The provisional appointment of the candidate is subject to the final outcome of the case, if any pending in any Hon'ble court of law, which may not be immediately within the knowledge of this office.
