**Subject:** Complaint lodged by Yangchan Dolkar, Lecturer HSS Turtuk, Leh.

**ORDER No.** 2546 **DSEK of 2015**

**Dated:** 09 /10/2015

> Whereas, Administrative Department vide No. Edu/Gaz-A/06/2015 Dated: 04/02/2015 has forwarded a representation of one Yangchan Dolkar, Lecturer HSS Turtuk Leh alleging therein that she has been harassed by the authorities, and requested to revoke the harsh punishment of "días-non" issued by D.C Leh in her favour on the merits of the case;

> Whereas, the Administrative Department desired to enquire into the averments made by the said lecturer through Joint Director of DSEK;

> Whereas, Joint Director (EE) was appointed as enquiry officer vide order No. 400 DSEK of 2015 Dated: 28/02/2015;

> Whereas, the enquiry report submitted by the enquiry officer reveals that the said lecturer had lodged a complaint against Z.E.O Nobra for using un-parliamentary language and an enquiry was ordered by the DDC Leh who attached the lecturer to DC Office vide order dated 08-10-2015;

> Whereas, on the receipt of the enquiry report submitted by the SDM Nubra, the lady lecturer was detached and directed to report her original place of posting vide order No. 557 Edu of 2013 dated 19-12-2013

> Whereas, the said lecturer was not allowed to join the said Institution by the Principal consequently DDC Leh vide order No. 236 Edu of 2014 dated 11-04-2014 placed the said officer under suspension and attached her with CEO Leh;

> Whereas, the said lecturer was reinstated by the DDC vide order No. 367 Edu of 2014 dated 27-06-2014 and treated the period w.e.f 19-12-2013 to 18-03-2014 as on leave and the period w.e.f 19/03/2014 to 27/06/2014 as on días-non;

> Whereas, the period from 19-12-2013 to 18-03-2014 falls under winter vacations and the period 19-03-2014 to 27-06-2014, the lecturer has attended her duties at CEOs office Leh;

> Whereas, the records available in the file and the recommendations made by the enquiry officer have been fully examined by this office on the merits of the case which depicts that this is a typical case of miscarriage of justice as D.C Leh has not taken all the facts on board and has taken the decision in haste in settling the suspension period.

**Now, therefore, the review petition is accepted and the recommendations of the enquiry officer are accepted. The period of suspension as decided by the D.C Leh vide the order under review is decided as under:**

- (i) 19-12-2013 to 18-03-2014 as winter vacation availed by the Lady lecturer.  
(ii) 19-03-2014 to 27-06-2014 as on duty.

**The entries if made in the Service records of the Lady lecturer in pursuance to the reviewed orders are hereby expunged from the records.**
