

The deputation shall be subject to the following explicit terms and conditions:-

1. That the selectee Teachers are required to report to the Dean School of Education, Central University;
2. That the deputees (in-service Teacher) had not been nominated for such training earlier;
3. That none of the deputees listed in the Annexure to this Order holds **Adhoc/FAT/Fake/fraudulent/ReT /Migrant substitute / probation status or is under suspension or is not in active service**. In the event of such an instance, if any detected on verification the selectee shall not be relieved for the Course and the matter in that case shall be referred to this Office for seeking further instructions/orders in respect of such deputees.
4. That a deputees who may be working against long or short term leave arrangement or against a lien post of any migrant Teacher shall not be relieved for the Course;



5. It shall be the responsibility of the concerned Chief Education Officer and the Head of Office/Institution to verify the particulars of each deputees with reference to his/her Service Book and the original testimonials, before relieving for the Course. He should also satisfy himself that the qualification /date of Ist appointment / adjustment / promotion /regularization as Teacher and other particulars are correct.

Note:- The date of first appointment as Teacher or in case of FAT/ReT/Migrant substitute shall be the date of regularization and not date of entry into service on a non-teaching/Class IV post;

6. In case any variation is found in the particulars and a deputees is found in eligible for such deputation the same shall be brought to the notice of this Office and no such Teacher shall be relieved for the Course;
7. That each deputees must have passed his/her graduation or equivalent degree prior to the date of issuance of this Order through a recognized University, either before appointment or after proper permission from the competent authority;
8. **The selected Teachers will be required to attend the duties in the School where they have been posted every day after attending the said Course.**

The concerned Chief Education Officer/Drawing and Disbursing Officer will verify the original certificates before effecting to the deputation order subject to the above conditions.
