**Sub:-** Select list of the candidates for the post of Teacher (Education Department) District Cadre Budgam in pursuance to the advertised Notification No's 03 of 2012, 05 of 2013 and 06 of 2013 (Item No's 271, 452&410) respectively and operation of wait list thereof.

**Ref:-** Administrative Department vide letter No. Edu-I/288/2014, dated 30.03.2015.

**ORDER NO. 2664 DSEK OF 2015**  
**DATED: 31 / 10 / 2015**

Whereas, the Administrative Department vide letter No. Edu-I/343/2014 dated 20.10.2014 forwarded the list of 326 candidates selected as Teachers for District Cadre Budgam pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/8253-59 dated 24.09.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department vide letter No. Edu-I/343/2014 dated 19.08.2015 forwarded Secretary SSB's Order No. 338-SSB of 2015 dated 31.07.2015 and Order No. 339-SSB of 2015 dated 31.07.2015 dated 16.07.2015 wherein the selection of **S.No. 30 under RBA Category** against Item No. 410 (06 of 2013) has been cancelled (which was earlier kept blank owing to her M.Ed degree from Singhania University) and some change has been made in the select list as S.No. 2 and 25 under OM Category against Item No. 410 (06 of 2013) were kept blank owing to the fact that the candidates who were making grade for selection at the said serials were having Graduation in Distance Mode from Jiwaji University (institute of Distance Education)/02 years PG Diploma from IITM (Tourism and Travel) and M.Ed from CMJ University, which were not considered by the SSB;

Whereas, in the backdrop of the situation enumerated above, **two (02) points** from the overall merit of **Reyaz Ahmad Bhat S/o Mohd Ramzan Bhat** and **Three (03) points** from overall merit of **Navida Ashaq S/D/o Mohsin Hassan** have been deducted from their overall merit. After deducting these points Reyaz Ahmad Bhat S/o Mohd Ramzan Bhat (S.No. 2/OM) shall again fall within the selection zone at **S.No.97/OM** (whose full particulars/merit position is awaited) and Navida Ashaq S/D/o Mohsin Hassan (S.No. 25/OM) will now figure under waiting list at S.No. 26/OM against Item No. 410 (06 of 2013).

Whereas, while issuing cancellation to the recommendations of candidates, the SSB remained mum as to whether these slots are to be filled by utilizing wait list or not. Accordingly, the matter was taken up with the Administrative Department vide this office letter No. DSEK/Estt/III/ 65879 dated 19.08.2015.

Whereas, the Secretary SSB. vide letter No. SSB/Sel/Secy/9949-50 dated 24.09.2015 conveyed that "in case a post gets accrued due to cancellation of a slot under a particular item, wait list can be operated against that slot under the said category provided the list has got validity of one year period".

Whereas, due to expulsion of S.No. 25/OM (Item No. 410 of Notification 06 of 2013) from the selection zone, one slot became available under OM Category in the same item & notification for operation of wait list. As such S.No. 1/Wait (Syed Zubair Ahmad) under OM Category Item No. 410 (06 of 2013) makes it to the selection zone.

Whereas, the Administrative Department vide another communication No. Edu-I/343/2014 dated 01.09.2015 forwarded Secretary SSB's letter No. SSB/Sel/Secy/2015/5778-79 dated 11.08.2015 wherein the recommendation in respect of one candidate namely Shabir Ahmad Ganie S/o Assadullah Ganie has been released, whose name was kept blank against **S.No. 2/Wait** under **OM Category of Item No. 271(03 of 2012)** also against **S.No. 3/Wait** under **OM Category of Item No. 452 (05 of 2013)**. However, due to deduction of 02 Points from his overall merit (owing to the fact that he has completed his PG degree through Distance Mode), his position changed from **S.No. 2/Wait** to **S.No. 3/Wait** Item No. 271(03 of 2012) and from **S.No. 3/Wait** to **S.No. 11/Wait** under OM Category of Item No. 452 (05 of 2013) with revised merit position **66.5506** points.

Whereas, the above named candidate (Shabir Ahmad Ganie) was figuring at two places in the wait list i.e. at **S.No. 2/Wait** under OM Category of **Item No. 271(03 of 2012)** and also against **S.No. 3/Wait** under OM Category of **Item No. 452 (05 of 2013)**, as such paving way for **other two candidates, one from Item No. 271(03 of 2012)** and another from **Item No. 452 (05 of 2013)** to enter into the selection zone.

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 desired to issue the provisional appointment orders in favour of the candidates for the post of teachers selected by the SSRB after taking the undertaking from the appointee with the following explicit conditions:-

**The salary in favour of the selected candidates is only drawn:-**

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department, all the **Four (04)** candidates furnished their undertakings on the devised format duly attested by the 1<sup>st</sup> Class Magistrate in the Directorate of School Education Kashmir in response to this office Notification No. DSEK/Estt/III/B-Trs/66438-42 dated 07.10.2015 for favour of further necessary action;

Now, therefore, pursuant to Administrative Department's letter No. Edu-I/288/2014, dated 30.03.2015 and SSB's No. SSB/Sel/Secy/9949-50 dated 24.09.2015, sanction is hereby accorded to the provisional appointment of **Four (04)** candidates as Teachers in District Cadre **Budgam** against the available slots in various categories as per the Annexure to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate are required to report to the Chief Education Officer, **Budgam** by or before **15<sup>th</sup> November, 2015** for further posting.

**The Chief Education Officer Budgam shall allow the candidates to join on the post after verifying the following certificates (in original).**

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.


The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
