Subject:- Grant of promotion In-Situ of Higher Standard pay scale.

ORDER NO. 27 DSEK OF 2017.

Sanction is hereby, accorded to the grant of (In-Situ) promotion of the Higher pay scale in terms of J&K Civil Services (Higher Standard Pay Scale Scheme Rules 1996 and SRO-14 Dated.15.01.1996), in favour of **16 (sixteen)** Non teaching / Class-Iv officials of District Baramulla, in the corresponding pay scale / pay band/ grade pay as shown against each, on notional basis, however with monetary benefit w.e.f 1st January, 2014, in terms of rule **2.43 of Financial code Vol.I.**

The promotion In-situ to the higher standard pay scale in favour of the non-teaching / Class-IV Officials, whose detailed particulars are shown in the Annexure is granted/ released subject to the fulfilment of the following conditions.

1. That the Chief Education Officer Baramulla/ Drawing and disbursing officer concerned will verify the particulars of each official with reference to his/ her original services records before allowing (In-Situ) promotion benefit and he shall be personally responsible for correctness of the particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and the case referred to this Directorate for further orders/ clarification.
2. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated.15.01.1996.
3. That the incumbents were not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory.
4. That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employees.
5. That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego his functional promotion in future.
6. That the work and behaviour of the officials has remained satisfactory during the preceding 03 (three) years.
7. That before implementing the order, the CEO Baramulla shall ensure that the employees are holding substantive post and his/ her appointment is genuine, before endorsing this order to sub- office for implementation.
8. That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any employee.
9. In-case, if it has been found that the time bound promotion has been sanctioned in favour un-regularized Migrant substitute / contractual by virtue of this order, the same should not be given effect.
10. That the upto date service verification in respect of S.No. 5-9 and S.No. 11 is got recorded in their respective service books before implementation of the order.
11. Consequent upon grant of HSP's pay & shall be regulated strictly in accordance to the provisions laid down in SRO-14 and SRO-94 dated.15-04-2009 and Govt.Order No.07-F and Govt order No.08-F dated.18/01/2011 read with SRO-42 dated.02/02/2011 and govt Order No.238-F of 2011 dated.30.09.2011 in addition rules 2.43 of F.C Vol-I be also implemented while Implementation of the (In-Situ) promotion order.
12. It shall be personal responsibility of the concerned Chief Education Officer to verify the particulars of each employee and observance of all Codal formalities and conditions mentioned herein above and the DDO's concerned shall give effect/ draw the arrears on account of time bound promotion after getting the entries to this effect recorded in the service book, duly countersigned by the Concerned Chief Education Officer.
