Pursuant to release of recommendation by J&K Services Selection Board vide communication No. SSB/Secy/Sel/39/2019/398-400 dated 18.01.2021, conveyed by Administrative Department vide above referred communication, sanction is hereby accorded to provisional appointment of Mr. Mohamad Ashraf Khan S/o Ghulam Hassan Khan (whose full particulars are reflected below) as General Teacher in District Cadre Pulwama in the Pay Level 5 (Rs. 29,200-92,300/-), as admissible under SRO-193 of 2018, dated 24.04.2018 under SRO-202 of 2015 dated 30.06.2015 as amended vide S.O. 194 dated 17.06.2020.

The conditions of probation, pay and allowances and fixation of initial tenure of the appointees shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK (GAD) of 2020 dated 19.06.2020.

The appointees shall report to concerned Chief Education Officers within a period of 21 days from the date of issuance of this appointment order and shall be allowed to join only after production/submission of following documents/certificates in original to be verified subsequently:

- i. *Academic Qualification Certificates*
- ii. *Date of Birth certificate.*
- iii. *Permanent resident certificate*
- iv. *Health certificate from the concerned Chief Medical Officer of the District*
- v. *Discharge certificate from the Institution attending/last attended*
- vi. *Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.*
- vii. *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*

The appointment of the candidate shall be subject to following conditions:-

(a) That he shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that:-

- i. *In case, at any stage, it emerges that the certificates/any relevant document furnished/produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.*
- ii. *in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by concerned Chief Education Officer, his/her appointment shall itself stand cancelled ab-initio and he/she shall have no claim to his/her appointment.*

- (b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) & (ii) above are received in his/her favour.
- (c) The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- (d) In case of failure to join within stipulated time period of 21 days, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.
- (e) The appointment shall be subject to the final outcome of the cases/writ petition, if any, pending before any Hon'ble Court which may not be immediately within the knowledge of this directorate.

The inter-se seniority of the appointee in the particular grade/service shall be fixed in terms of Rule 24 of CCA Rules, 1956.


